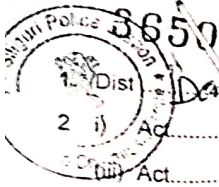

I, Sri Raja Majumdar son of Late Heeralal Majumdar, resident of Bipin Pal Sarani, Collegepara, Siliguri, Post Office and Police Station – Siliguri would like to inform you that yesterday at around 6.45 P.M when my niece (sister's daughter) namely Anushree Ghosh daughter of Sri Sushil Kumar Ghosh, residing at Rashbehari Sarani, Ghosh Para, Hakimpara, Siliguri, Post Office and Police Station- Siliguri was standing in the parking area outside Amina Restaurant, near Panitanki Outpost, Post Office and Police Station- Siliguri- 734001, District- Darjeeling, a vehicle bearing no. WB-74-AX-7459 being rashly driven hit her causing her severe body injury. Later on she was taken to Siliguri District Hospital and was further shifted to Mukherjee Hospital, Hill Cart Road, Siliguri, Post Office and Police Station- Siliguri, where she is struggling for her life.

Lastly requesting you to do the needful to punish the culprit as per provision of law.
