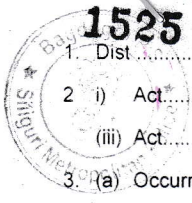

Sub: Complaint regarding misbehaviour with maintenance staff

Respected Sir,

I, Sumit Koner, S/O Susanta Koner, Station Manager, Bagdogra Customer Care Center do hereby lodge this complaint against Bikash Biswakarma, S/O Dilip Biswakarma, Vill: Bhujjapani, PO: Bagdogra, PS: Bagdogra, Dist: Darjeeling for misbehaving and assaulting Mr. Basant Paswan, S/O Lt. Ramcharan Paswan, working in emergency maintenance work as contractual staff engaged for M/S BONA ENT. under Bagdogra CCC, WBSEDCL.

On 18.01.2023 Mr. Basant Paswan submitted one complaint in the office of the Bagdogra CCC, WBSEDCL stating that one person named Bikash Biswakarma alongwith one more person (Named Unknown) has misbehaved and assaulted him around 4 PM in office campus, due to which he has been injured and submitted to hospital for better care. After enquiring with other staffs about this incident named, Sri Roshan Limbu (Sr. TSH, M. NO: 9775815845), Sri Manik Adhikari (Security Guard, M.No: 8372063778), Sri Anirban Paul (CFO, M.No: 9474681277), Sri Ashish Bodra (KIOSK Operator, M.No: 8617594589) and watching the CCTV recorded video of the incident it may be concluded that Bikash Biswakarma has committed an offence by assaulting Mr. Basant Paswan along with one more person during duty time in office campus. This kind of misbehaviour towards maintenance staff of electric department is really disheartening and strict action should be taken against it.

Thus you are requested to take necessary action and kindly treat this as F.I.R. Thank You.
