I **SMT. BIBHA SAHANI**, D/O - Late Rajendra Sahani, W/O Sri Mukhesh Sahani, Presently residing at Santosh Nagar, Ward No. 5 of S.M.C., Siliguri, P.O. and P.S. Siliguri, Dist - Darjeeling (West Bengal), do hereby want to inform you that :-

1. That I, was married to Sri Mukhesh Sahani, S/O Sri Debo Sahani, R/O Durga Nagar, Kumartoli, Ward No. - 4 of S.M.C., Mahananda Para, P.O. Siliguri Bazar, P.S. - Khalspara Fari, District - Darjeeling, who is the School Teacher of Adarsh Vidyalaya Hindi High School (H.S.) at Odlabari, according to the Hindu Rites and Customs on **21.06.2021**.

2. That during my arrangement of the marriage ceremony, my husband and my mother in law namely Sova Sahani, W/O Debo Sahani, father in law namely Debo Sahani, S/O - Not Known, Elder Brother In Law Rakesh Sahani, S/O - Debo Sahani, Younger Brother In Law Mithilesh Sahani @ Rajesh Sahani, S/O - Debo Sahani, All are R/O Durga Nagar, Kumartoli, Ward No. - 4 of S.M.C., Mahananda Para, P.O. Siliguri Bazar, P.S. - Khalspara Fari, District - Darjeeling, suddenly started to demand cash dowry and gold ornaments and furniture from my mother and brothers and also pressurized me and my mother and brothers that if we did not provide all the demanded articles to my husband before marriage ceremony then they will cancel the marriage ceremony. Thereafter as per the demand of my husband and other above mentioned in laws, my mother and brothers has given them cash dowry of Rs. 40,00,000/- (Rupees Ten Lakh Only), Gold ornaments of 6 Bhari approx, Silver ornaments of 20 Bhari approx, cash amount of Rs. 70,000/- (Rupees Seventy thousand Only) for purchasing a Bike, Wooden furniture of Bed, One Godrej Steel Almira, Dressing Table, Sofa, Fridge, All utensils of Kasha costing approx Rs. 20,000/- (Rupees Twenty Thousand Only) along with costly cloths and other valuable articles to my husband and other above mentioned in laws at the time of marriage ceremony in presence of other relatives. Irrespective of giving all the articles to my husband and other above mentioned in laws with other relatives criticized my mother and brothers by saying that all the dowry articles including the cash dowry did not met their expectation.

3. That my husband is a teacher of Adarsh Vidyalaya Hindi High School (H.S.) at Odlabari and due to his service he is temporarily residing there. Moreover at the time of marriage my husband and other in laws assured me and my mother and brothers that after the solemnization of marriage ceremony and after the completion of all the rituals my husband will take me to Odlabari to reside with him. But after the solemnization of marriage my husband never took me to Odlabari to reside with him and I also realized that my husband used to come home very frequently and only stay for only 2 or 3 days in a week in the matrimonial house. Moreover soon after the marriage my husband (whenever he used to visit the matrimonial house) along with other above mentioned in laws started to torture me and also abusing me by saying that all the dowry articles did not met their expectations and started to pressurizing me to provide more dowry from my mother and brothers.
4. That after marriage my husband and other above mentioned in laws in the house used to abused me in most filthy language and even tried to kill me by keeping the gas oven open in the kitchen when I went to make tea in the evening. I was saved due to her own alertness. My husband and other above mentioned in laws used to abuse and insult me and my family members in front of neighbors and they all took advantage of the fact that I could not express all these in front of my mother and brothers or any other family members. Through out of the day I was tortured by my husband and other above mentioned in laws and at night if I dared to ask for help my husband used to beat me and accuse me for not bringing enough dowry.
5. That this is to mention here that my above mentioned 2 (Two) brother in laws namely Mithilesh Sahani @ Rajesh and another namely Rakesh Sahani who reside in the matrimonial house always used to taunt and abuse me in every pity matters. My above mentioned brother in laws always try to abuse me in filthiest languages and often used to beat me with fist and blows and whenever I used to protest the said behavior of them, they used to threat me with dire consequences. The other in laws of the house never ever protested such kind of behavior of the my above named brother in laws.
6. That from the first day of my marriage I used to stay at my matrimonial house at Durganagar since 2021 from the day of my marriage. Since that day, my husband never ever provided my necessary expenses to me. Moreover my husband and other above mentioned in laws in the house always used to abuse me for not bringing enough dowry and also used to abuse my mother and brothers in front of all the family relatives and neighbors and whenever I tried to protest the same they used to constantly

torture upon me both mentally and physically and let me down in every aspect in the house. They often used to insult me in front of all the family members and neighbors and when I tried to protest the same they used to beat me cruelly and used to shut my mouth so that I could not express the matter to my mother and brothers.

7. That from the beginning my mother and brothers tried their level best to fulfill all their demands but my husband and other above mentioned in laws never ever satisfied with them. Rather their demand increased day by day and my husband used to create such helpless situation so that my mother and brothers became bound to fulfill their demands. Moreover my husband and other in laws always used to pressurize my mother and brothers to give them money and whenever I tried to protest such kind of behavior they used to beat me mercilessly.
8. That my husband and my mother in law also took all the stridhan property along with other valuable gifts and costly items which were received during the marriage ceremony from my custody soon after marriage and always used to insult me for not bringing that much dowry as per their demand. Moreover whenever my mother and brothers did not fulfill their demand my husband and other above named in laws always used to torture me and pressurize me for bringing more dowry from my mother and brothers and also threatened me that if my mother and brothers failed to fulfill their demand then they will rearrange the marriage of my husband and throw me out of the matrimonial house.
9. That subsequently since the month of February 2022 my husband suddenly stopped to contact with me and also did not visit the matrimonial house since then. At this I on several occasion tried to contact with my husband but my husband refused to talk to me without any realm and reason. At this I apprehend that my husband may be engaged in any illicit relationship with someone as he always refused to take me to Odlabari with him and also suddenly stopped to contact with me since then. Subsequently in the month of May 2022 when I told my in laws to send me to Odlabari wher my husband resides then my above mentioned brother in law named Mithlesh @ Rajesh Sahani and Rakesh Sahani started to misbehave with me and abuse me with filthiest languages about my character and also threatened me that they will disobey my modesty in front of everyone and there was no one in the house to protest them and started to create great chaos in the matrimonial house, when I tried to protest the same then my above mentioned brother in laws along with other in laws in the house started to torture me both mentally and physically and threatened me that they will throw me from the matrimonial house and will

rearrange another marriage for my husband if I failed to convince my mother and brothers to provide more dowry for them and also threatened me with dire consequences.

10. That subsequently in the month of October 2022 my mother in law forcefully taken me to my parental house leaving all my personal things and gold jewelries and all other Stridhan properties and was taken to my parental house forcefully by my father in law and mother in law.
11. That thereafter me and my mother and brothers on several occasion tried to contact with my husband and other in laws, but they all refused to talk to me my mother and brothers. Subsequently I became mentally depressed to that extend that I has to take medical support for my health and considering my mental and physical condition my mother and brothers on several occasion tried to take me to my matrimonial house and requested my in laws to allow me to enter in my matrimonial home, but they all never ever allowed me to enter the matrimonial house.
12. That at present I am living in very depressed condition and became mentally and emotionally ruined due to the above mentioned cruel acts and conducts of my husband, my mother in law namely Sova Sahani, W/O Debo Sahani, father in law namely Debo Sahani, S/O - Not Known, Elder Brother In Law Rakesh Sahani, S/O - Debo Sahani, Younger Brother In Law Mithilesh Sahani @ Rajesh Sahani, S/O - Debo Sahani. That the sole intention of my husband and the above named in laws is to put me in such a condition so that I bound to die due to the above acts and conducts and they can easily rearrange the marriage of my husband for dowry.
13. That subsequently finding no other alternative I send one Legal Notice to my husband requesting him for taking me back to the matrimonial house on 19.01.2023, but after receiving the said notice my husband never took any initiative to take me back to the matrimonial house, rather since after receiving the said Legal Notice, my husband and other above mentioned in laws started to threatening me that if I take any kind of legal action against them the they will kill me and my family members as such they are trying to rearrange the marriage of my husband to another women.
14. That on October 2022 on several occasions I tried to contact with my husband and was waiting whether he would take me to my matrimonial house, but they did not communicate with me and so I waited for my husband and did not lodged any F.I.R. against them.

I therefore request before your good self to kindly look into the matter and take necessary action against my husband and the above named in laws as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
