Respected Sir,

I Debayan Ghosh, Son of Late. Dilip Ghosh, resident of Ramkrishana Pally, Bidhan Nagar, P.S. Phansidewa, Dist- Darjeeling, begs to report you the following:-

1. That one Nabarun Dey @ Jango, Son of Bapi Dey, resident of Shanti Nagar, Binay More, P.S. Bhaktinagar, Dist- jalpaiguri is known to me.
2. That in the year 2021 in the month of November he called me up and said me that a case has been registered in my name under siliguri P.S. and the case is a very serious one and in such case the police may arrest me without any notice to me and if I get arrested I won be given bail as the sections are non bailabe in nature after hearing this I told him that I am not into any kind of illegal activities and neither I have done any offence or any kind of illegal activity but even then he induced to beehive me that a serious case has been registered in my name. After telling all this the said Nabarun Dey @ Jango told me that he has a very good hold as well as very good setting with all the officers of siliguri and further said that he has done all the setting with the officers and even the officer is ready to remove my name from the said case and even they wont arrest me but in order to do all this I will have to pay Rs. 1,20,000/- so that the said Nabarun Dey @ Jango can give that money to the officer and do the setting with them.



3. That I informed this matter to my family and told the entire story after which my family suggested me to give the said money and get the matter settled and not to get involved in the court case or police thing and after with I requested my mother to give me a loan of the said amount but my mom could only give me Rs. 60,000/- and after getting the said loan from my mom I asked the said Nabarun Dey @ Jango when and where do I have to come to give him the money and for the same he asked me to come down to siliguri and call him and also asked me to meet him in near Pakurtala more in siliguri.
4. That after few days of his communication later in the month of November, 2021, I called him up over the fone and asked him where to meet him and at what time, to which he said me to reach Pakurtala more by 3:30 PM, at the time said by him I reached the spot and met him where he was standing in a corner and he asked me the money after which I said him that I did not carry such a huge sum of money so I will do a online transfer to which the said Nabarun Dey @ Jango did not agreed initially but later on asked me to do the payment in his Phone pay number through Online to his said contact number 79088-73171, after getting this number I called my mom and said her to do the online paymen in the said number. To which my mom got the money transfred through Sanju Store at Bhimbar Bidhan Nagar . After my mom made the payment of Rs.60,000/- I asked him now nothing will happen against me to which he said he had done the setting in Rs. 1,20,000/- and I gave him half of that and also said that its very difficult to do the setting of the officer in the half amount. The said Nabarun Dey @ Jango said me to go after taking the koney and also said me if he needs more money he will call me.
5. That after giving him the said money the said Nabarun Dey @ Jango did not call me neither informed me about the case was dismissed against me or not but as the days passed I thought the setting was done and the case was dismissed but few days back again he called me and was asking me more money or els I will be implicated in another case by the siliguri P.S.

as because I have not give them the other half money to which I flatly denied and said Nabarun Dey @ Jango very clearly that I wont be able to give any money to him noe for anything tho which he thretned me with dire consequences as he has a very good hold and setting with the officers.

6. That few days back I came to know from one of my fried that the said Nabarun Dey @ Jango is a cheater and has cheated him also and many other peoples with a huge sum of money in the name of Police and misappropriated a huge sum of money and also extorted many innocent people like me and my fried.

7. That I came to know about this incident I tried contacting with him and asked him to return my money to which he said that if I ever call him for money I will have to face dire consequences and if further disturbe him for the money then he will get me killed and throw my body in the river.

I therefore request you to kindly take necessary legal action against the aforesaid Nabarun Dey @ Jango as he has cheated me and many other people and extorted a huge sumk of money from many people in the name of setting and settling the case with the Police officers of siliguri.
