Sub: Complaint against my husband Subesh Rai, Son of Sri Mitra Kumar Rai, my brother-in-law, Mahesh Rai, Son of Sri Mitra Kumar Rai, my Sister-in-law, Dipa Rai and Anuka Rai, both are daughter of Sri Mitra Kumar Rai and my Jaa, Smt. Trishna Rai, Wife of Sri Mahesh Rai, all are resident of Upper Ghumti Gaon, (Rocky Island), Samsing, P.O. Mateli, P.S. Jhalong, Dist. Kalimpong.

Respected Sir,

I, **Smt. Dawa Dolma Tamang** @ **Reshmi Tamang**, Wife of Sri Subesh Rai, presently residing at Shantipara, Salugara, Ward No.42 od S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my husband Subesh Rai, Son of Sri Mitra Kumar Rai, my brother-in-law, Mahesh Rai, Son of Sri Mitra Kumar Rai, my Sister-in-law, Dipa Rai and Anuka Rai, both are daughter of Sri Mitra Kumar Rai and my Jaa, Smt. Trishna Rai, Wife of Sri Mahesh Rai, all are resident of Upper Ghumti Gaon, (Rocky Island), Samsing, P.O. Mateli, P.S. Jhalong, Dist. Kalimpong, to the effects as follows:-

- (1) That my marriage was solemnized on 04-02-2017 along with said Subesh Rai as per Hindu rites and customs and has been living and cohabiting together as husband and wife at my matrimonial home i.e. at Upper Ghumti Gaon, (Rocky Island), Samsing, P.O. Mateli, P.S. Jhalong, Dist. Kalimpong,
- (2) That out of the said wedlock, I gave birth to a female baby namely Saira Rai on 29-02-2020 but the original birth certificate of my daughter is in the possession and custody of my husband and in-laws.
- (3) That since after 2 months of marriage, my husband with aid and abetment of my in-laws abused me in filthy languages and physically assaulted me with water connection pipe.
- (4) That when I was 9 months pregnant, my husband with the aid and abetment of my in-laws verbally abused and physically assaulted me and drove me out of my matrimonial home and threw away all my clothes and belongings but with the help of some local people somehow able to re-enter into my matrimonial home again.
- (5) That my sister-in-law, Anuka Rai also verbally abused me and tried to attacked me with Khukri with an intention to caused grievous injury upon me.
- (6) That my husband has been suspecting me of having extra-marital affairs with other men and due to which with the help and abetment of my in-

laws frequently used to abuse me in immodest and obscene languages and used to physically assault me with slaps and kicks and sometimes with bucket and chairs.

- (7) That due to unbearable mental and physical torture upon me inflicted by my husband with the incitement, instigation, aid and abetment of my inlaws tried to commit suicide by hanging at my matrimonial home but the mental and physical torture did not stop rather it extended to such an extent that under compelling circumstances, I along with my minor daughter left my matrimonial home on 12-12-2022 and came to my parental house at Shantipara, Salugara, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri within the jurisdiction of this police station.
- (8) That on 19-12-2022, my husband came to my parental home and again abuse me in filthy languages and physically assaulted me by pushing my face with his hand towards the wall and threatened me of lodging false complaint against me and my family members and put us behind the bar.
- (9) That on 24-01-2023, my brother-in-law, Mahesh Rai came to my parental house and forcefully tried to take away my minor daughter but due to our strong protest, he could not take her but threatened me and my family members to implicate us in false case.
- (10) That since then my husband and in-laws have been continuously threatening over my and family member's mobile phones of causing grievous injuries, of taking away of my minor daughter forcefully and of implicating us in false case and thereby causing continuous mental torture upon me.

So, therefore, I humbly request you take stringent legal action against my said husband and my in-laws as per provision of law at an earliest.

I shall ever remain grateful for the needful and be obliged thereby.
