

With due respect, I am producing herewith the arrested accused persons namely (i) Chotu Mahato (18) s/o Jangli Mahato of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (ii) Sunni Chowdhury (22) s/o Ashok Chowdury of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (iii) Joynal Ali (22) s/o Azger Ali of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (iv) Md. Raju (32) s/o Md. Akhlim of Soth Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (v) Tubai Das (26) s/o Lt. Gosai Das jof PWD More, Sitalapara, PS-New Jalpaiguri, Dist.-Jalpaiguri and the following articles under seizure :-

- I. One Iron made Hasua and one Iron made sabol, & One blunt Iron Rod from the possession of accused Chotu Mahato (18) s/o Jangli Mahato of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri.
- II. One sharp cutting knife and one plastic made charger torch light and Iron Road from the possession of accused Sunni Chowdhury (22) s/o Ashok Chowdury of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri.
- III. One Iron made Hasua, Screw Driver & One Blunt Iron Rod from the possession of Joynal Ali (22) s/o Azger Ali of South Colony, PS-New Jalapaiguri, Dist.- Jalpaiguri.
- IV. One Iron made Bhojali and one sharp cutting knife, One Torch Ligh, one Blunt Iron Rod from the possession of accused Md. Raju (32) s/o Md. Akhlim of Soth Colony, PS- New Jalpaiguri, Dist.- Jalpaiguri.
- V. One Iron made Bhojali and one sharp cutting knife, One Torch Ligh, one Blunt Iron Rod from the possession of Tubai Das (26) s/o Lt. Gosai Das jof PWD More, Sitalapara, PS- New Jalpaiguri, Dist.- Jalpaiguri

I, SI Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to state that on 27.01.2023 at 0315 hrs I received a secret source information that a gang of miscreants come to Porajhar, near Rail Gate, PS-New Jalpaiguri, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Porajhar area, PS- New Jalpaiguri, Dist- Jalpaiguri. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 1166 dated 27.01.2023. As per kind order and direction of my superior officer myself along with ASI Sajal Das, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy CV/824 Niru Kumar Yadav all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Porajhar, PS-New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. I also informed the fact to night RT Van officer SI-Pranab Singh of New Jalpaiguri PS, Siliguri Police Commisionerate along with force and directed him to come to Porajhar to accompany with us. At about 0325 hrs on 27.01.2023 we arrived at Porajhar, PS-New Jalpaiguri PS, Siliguri Police Commisionerate. After a while SI Pranab Singh along with force came to Porajhar and accompany with us. At about 0355 hrs we found that 09/10 persons assembled in a dark place at Porajhar, near Rail Gate, under New Jalpaiguri PS, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee

the police party they started to flee away but we the police party managed to apprehended 05 (Five) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity at Porajhar. On search of the apprehended accused persons I found (i) One Iron made Hasua and one Iron made sabol, & One blunt Iron Rod from the possession of accused Chotu Mahato (18) s/o Jangli Mahato of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (ii) One sharp cutting knife and one plastic made charger torch light and Iron Rod from the possession of accused Sunni Chowdhury (22) s/o Ashok Chowdury of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (iii) One Iron made Hasua, Screw Driver & One Blunt Iron Rod from the possession of Joynal Ali (22) s/o Azger Ali of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (iv) One Iron made Bhojali and one sharp cutting knife, One Torch Light, one Blunt Iron Rod from the possession of accused Md. Raju (32) s/o Md. Akhlim of Soth Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (v) One Iron made Bhojali and one sharp cutting knife, One Torch Light, one Blunt Iron Rod from the possession of Tubai Das (26) s/o Lt. Gosai Das jof PWD More, Sitalapara, PS-New Jalpaiguri, Dist.- Jalpaiguri.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity at Porajhar area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted four accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 0425 hrs to 0505 hrs.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Chotu Mahato (18) s/o Jangli Mahato of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (ii) Sunni Chowdhury (22) s/o Ashok Chowdury of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (iii) Joynal Ali (22) s/o Azger Ali of South Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (iv) Md. Raju (32) s/o Md. Akhlim of Soth Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri (v) Tubai Das (26) s/o Lt. Gosai Das jof PWD More, Sitalapara, PS-New Jalpaiguri, Dist.- Jalpaiguri and others and arrange for its investigation.
