With due respect I, Manasi Debnath (Chowdhury) daughter of Sudarsan Debnath wife of Arindam Chowdhury aged about 32 years resident of house no 469, military road, shantipur, P.O N.B.U P.S Matigara Pin 734013 was married to Arindam Chowdhury son of Arun Kumar Chowdhury resident of ward no 8, south colony, P.O & P.S Malbazar pin 735221 district Jalpaiguri on 14th February 2021 as per hindu rites and customs. Since the first night of our marriage my husband namely Arindam Chowdhury and with the instigation of my father in law Sri Arun Kumar Chowdhury and mother in law Smt Sabita Chowdhury started abusing me by using very filthy abusive and slang languages for the stridhan articles which are no according to their expectations. They also forced me every now and then to get more money and jewellery from my parents and when I denied doing so my husband pushed me and slapped me on a regular basis. My father-in-law namely Arun Kt. Chowdhury abused me in various ways.

As I am a working lady and required the marriage certificate in my various documentation for the purpose of my job I asked my husband to get our marriage legally registered but he also refused to do so. He further threatened me to abandon me as I do not match upto their expectations.. That my husband, namely, Sri Arindam Chowdhury was never interested in earning a single penny and lived his life on my earnings.

That my husband namely Arindam Chowdhury and with the instigation of my father in law Sri Arun Kumar Chowdhury and mother in law Smt Sabita Chowdhury always taunted me for my education and my work life and constantly demotivated me. They did not allow me to avail opportunities outside west Bengal as my husband Arindam Chowdhury unable to get any job. In the mean time I got a job in ADAMAS University in Kolkata. As it was covid period I came back to my matrimonial house after completing various official formalities required in the university. Their attitude towards me completely changed after I returned back from Kolkata. They hardly spoke to me and did not allow me to touch the household articles, also did not allow me to enter into the kitchen. They often poured soap water on the surface of the bathroom. On many occasion I felt down and got hurt but they did not take me for any kind of treatment. He had illicit extra marital affairs with many women. He used to hide his phone from me and received his calls away from my notice.

In the mean time I got a job in Nagaland University in the month of February 2022. He denied me to assist me mentally or physically to join the job. After which his attitude and behavior

completely changed towards me and accuse me of extra marital affair. After I went to Nagaland he declined my phone calls and messages with intention to ignore me. when I called my father in law he threatened me and abuse me in very filthy language. I kept calling my husband trying to reconcile to keep our marriage intact. His phone would remain engaged till midnight after which I learnt that he has various extra marital affairs.

That on 21st January 2023 my husband along with my father in law came to my parental house and started abusing me and force me to take me along with him to my matrimonial house and threatened me to make my life hell there when I refused to abide by them they pull me by my hair and slapped me tightly. When my father started to call for help they fled away. I request you to kindly look into the matter and take appropriate legal step against the above-named accused persons as I am passing my day in extreme fear and anxiety.
