Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Pradip Roy (24) s/o Hari Roy of Ullar Dabri, PO-Mainaguri, PS- Mainaguri, Dist.- Jalpaiguri and the following articles under seizure :-

1. One Dumper bearing registration No.-NL-01L-0931 loaded with sand.
2. One Poclain yellow in color written as L & T KOMATSU.

I, ASI-Khagen Barman presently attached with NJP PS under your kind control beg to state that today i.e. on 30.01.2023 at 0005 hrs I received a secret source information that sand is being illegally mined within 200 meters of Mahananda Bridge at near Noukaghat . Accordingly I diarised the fact in the General Diary vide New Jalpaiguri PS GDE No.- 1266 date:30.01.2023 and also informed the matter to Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate. As per kind direction and instruction of Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate myself along with force namely, VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for Mahananda Bridge No.- 03, near Noukaghat , PS- NJP, Dist.- Jalpaiguri in Mintu Ghat, Mahanandra River Bed No.- 06, PS-New Jalpaiguri, Dist.- Jalpaiguri to verify the verisity of the information. At about 0025 hrs we arrived at Mintu Ghat, Mahananda River Bed No.- 06, PS- New Jalpaiguri, Dist.- Jalpaiguri and being identified by the source I, held raid at Mintu Ghat, PS-New Jalpaiguri, Dist.- Jalpaiguri and found that One Poclain taking out sand within the radius of the 200 meters of Mahananda Bridge No.- 03 and loading in dumper having registration No.- NL-01L-0931. The driver of the Dumper with the assist of driver of the Poclain minning sand illegayly with in 200 meters redius of the Mahanda Bridge violating the lease aggrement as well as violating the government order and was dangerous for Mahanda Bridge which is a public property. consequently it could damaged the bridge which is Public Property. But seeing the Police Team the driver of the Poclain fled away from the spot but after a hot chase, we successfully, apprehended the driver of the dumper having registration No.- NL-01L-0931 and on being asked he disclosed his name and address as noted above and on further in. That there is sufficient reason to belive that the Driver of the said vehicle have stolen sand from Mahananda River Bank within 200 meters of Radius with the concent of Lease holder of Mahananda River Bed No.- 03, PS- New Jalpaiuri, Dist.-Jalpaiguri without Legal Authority/Paper as per rules, for selling the sand cledestinely for their wrongful gain. Accordinlgy, I seized One Dumper bearing registration No.-NL-01L-0931 loaded with sand and one Polain yellow in color written as L & T KOMATSU after preparing proper seizure list and arrested the accused

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused person namely Pradip Roy (24) s/o Hari Roy of Ullar Dabri, PO-Mainaguri, PS- Mainaguri, Dist.- Jalpaiguri and driver of Poclain, owner of the dumper and owner of the Poclain and Manager of L & T KOMATSU and lease holder of Mintu Ghat, Mahananda River Bed No.- 06, near Noukghat and others and kindly arrange for its investigation.
