Sir,

I Smt. Sneha Bhawal, W/o Shri Ratnadip Mukherjee, D/O- Shri Swapan Bhawal, residing at Near Rabindra Sarani Post Office, Ward No.21, Dist- Darjeeling, Pin- 734006 would like to state you that myself has lodged a complaint against the accused Shri Ratnadip Mukherjee for his illegal activities which is maligning my reputation and images in society and my life is at stake presently. That due to the torture humiliation I lodge one complaint against him and he took all my gold jewellery and demanded cash from me. He took around 2 lacs of cash and continued demanding dowry. I was astonished by seeing that my husband and my brother-in-law's wife viz. Tumpa saha in a offensive condition. Thereafter he tortured me physically and mentally more and tried to kill me. My husband abused my in various way. He is demanding more cash to continue the conjugal life. After that I am residing at Siliguri and thereafter through phone he called me time and again and forced me for mutual divorce and when I did not agreed with such proposal, he threatened me that he will ruin my life and after such incident ne never contacted me or I am having no connection with my husband and I am residing at my paternal house. But suddenly on 19.01.2023 one of my friend had send me screenshot of my picture uploaded in Porn site and I was totally shocked by seeing the picture and then on the very next day I have informed the matter to the Cyber Cell Police Station, Siliguri. The picture which was uploaded at the internet site was one of my private pictures which were clicked by my husband while we were leading our conjugal life and he stored the photos in his mobile phone and laptop. These kind of private pictures are only lying with my husband and now he is misusing the pictures, just to malign my reputation. Now with a malafide intention he is uploading the pictures at various online platforms. Be it stated that my husband loved to click pictures and while leading our conjugal life he clicked my several private photos too.

He came to siliguri and harassed me physically and threatened me that if I step out of my home he will rape me with some other boys and will ruin my reputation in siliguri. Recently he threatened me over phone and creating tremendous pressure upon me and my family.

He is very adamant in nature and to malign my reputation he can do anything. I am suffering from severe fear psychosis and I am mentally shattered from these kinds of incidents. Please take an early initiative or else he will ruin my image amongst everyone. My life and reputation is at stake, please do the needful as early as possible.

I kindly request you to look into the matter as early as possible personally or by your police personnel as because I am very much apprehensive that he may leak my private pictures on different internet site or social media. My entire life is in danger now. Kindly take strict action against him and save my life.

Sir, I kindly request you to take immediate action as per provision of Law against the offender and also take steps that he may not leak or upload any other pictures of mine in any Social Media Platform or at any Internet Site. Being a girl I am loitering around the police Stations time and again since fortnight but no step has yet taken and I am mentally traumatized from all these. Sir I would be much obliged if you kindly take the matter seriously and take quick action on it.

Thanking you and I hope you will take immediate steps on the accused person.
