Respected Sir/ Madam,

I, the attorney holder of Smt Beuty Rani Dey, W/o Late Rangalal Dey of Panchanai, Dt Darjeeling, would like to present the following details in regards to the above mentioned subject, that Smt Beauty Rani, is the absolute and registered owner of land measuring 1.64 Acres, situated in Mouja Barogharia, J.L No. 82, L.R Plot No. 2,6,7 and 8, L.R Khatian No. 84, P.S Matigara, located at near B. Ed College, by virtue of registered Sale Deed being No. 9484, in the year 2014 and registered at A.D.S.R Bagdogra.

1. That her name has been duly recorded in the ROR and opened a separate L.R Khatian being No. 2597 at the office of B.L & L.R.O Matigara Block at Sibmandir.
2. That one Priti Oraon, wife of Maltu Oraon with her associates of Dhukuria came to my land and with malicious intent and armed with dangerous weapons to encroach the land from 2019 to till date.
3. That Priti Oraon and her associates of Dhukuria first forcefully occupied my land.
4. That when I tried to stop them they threatened me with dire consequences.
5. That later it has come to my knowledge the they have sold my whole plot of land illegally without my knowledge and consent.
6. That this act of Priti Oraon and her associates of Dhukuria has caused tremendous mental agony and economical loss to me.
7. That Sir, we have lodged complaint against Priti Oraon and her associates of Dhukuria to the I.C. Matigara Police Station and the Matigara Police has also initiated criminal case against the said land encroachers.
8. That the Ld. Court passes an interim order but they did not follow the Ld. Court order and continuing their construction work on my said land.

I, therefore, request your good office to stop the initial construction work for a time being taken in my encroached land and also to take a strict legal action against them so as to save my land. That, I shall be grateful for your kind co-operation.
