Santoshi Singh W/o Sri Devanand Singh D/o Sri Arjun Singh presently residing at Nabagram, near Union Samity Kalibari, Opposite St. Joseph High School, P.O - Siliguri Town, P.S - NJP, District - Jalpaiguri, would like to inform you that on 13-6-1997 my marriage was solemnized with Sri Devanand Singh S/o Sri Suresh Singh resident of Ganga Nagar, Bhindi Khet, Ward No - 5, P.O & P.S - Siliguri, District - Darjeeling according to Hindu rites and customs at my aforesaid parent house. During my conjugal life I became the mother of Four children out of who two are sons namely Bikash Singh aged about 23 years and Manish Singh aged about 21 years, Abhisekh Singh aged about 20 years and one daughter namely Sreya Singh aged about 18 years. be it mention here that my husband is a driver by profession and I am working as a cook in a flat situated at Jharnalay, Milanpally, near electricity office, Siliguri, Darjeeling since last 4 years and due to mental and physical torture of my husband, I shifted myself at my parental house and performing my job of cook in the said apartment. Now my husband off and on used to came to my work place and without any reason used to pick hue and cry on the road by indicating me not only that he started picking up hue and cry with my employer so that they remove me from my job. My job is the only source of income to maintain myself. Madam I am afraid that my husband may inflict grievous injuries on my part at any point of time.

So requesting you to investigate the matter and take necessary legal action against him for the safety and security of my life and property.
