I, Sri Anil Acharya, S/O Late H.G. Acharya, Address:  
Newly Bhawanagar, (Near Tarun Tirtha Club), P.O. Rabindra  
Sarani - 734006, P.S. Siliguri, am to state that my  
two daughters, Smt Aparupa Acharya (F/27) and Smt  
Apabrita Acharya (F/23) met an severe road accident  
at about 5.30 p.m. near Seroke More, Siliguri on this  
day, i.e. 05/02/2003, while a vehicle (Fortuner-No. WB 74 P  
8205) hit an auto (no. not known) suddenly. The auto  
subsequently fell upon my daughters and my elder  
daughter was so seriously injured that she had to be  
shifted immediately to Siliguri Sadak Hospital where  
she had to undergo CT scan for her head injuries and  
switch several times over her nose. The other daughter,  
Smt Apabrita Acharya accompanied by the traffic  
constable somehow managed to shift Aparupa to  
Siliguri Hospital and admitted at Surgery ward against  
bed no 19.

This may kindly be accepted as F.I.R. and take
