Action taken : Since the above report reveals commission of offence(s) as mentioned at item No. 2., registered the case and took up the investigation / directed ASI Anur Kanti Ghosh to take up investigation / refused investigation / transferred to P.S. on point of jurisdiction. FIR read over to the Complainant/ Informant, admitted to be correctly recorded and a copy given to the Complainant / Informant free of cost.

In producing herewith two (02) arrested accused persons namely (i) Keshov Kumar Sharma (M/27), S/O- Sri Mahesh Prasad Sharma of Bankim Nagar, Ward No. 41, PS Bhaktinagar, Dist. Jalpaiguri c/o Soni home, Bholachowhan Road Road, PS Bhaktinagar, Dist. Jalpaiguri and (ii) Shivam Soni (26) s/o Hari Om Verma of 18/137 Bherogari, Devije ke, Mandir, Mathura, PS Kotwali, Dist. Agra fort, Uttar Pradesh along with as per enclosed seizure list.

I SI Abhishek Theengh of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted arrested accused persons namely (i) Keshov Kumar Sharma (M/27), S/O- Sri Mahesh Prasad Sharma of Bankim Nagar, Ward No. 41, PS Bhaktinagar, Dist. Jalpaiguri c/o Soni home, Bholachowhan Road Road, PS Bhaktinagar, Dist. Jalpaiguri and (ii) Shivam Soni (26) s/o Hari Om Verma of 18/137 Bherogari, Devije ke, Mandir, Mathura, PS Kotwali, Dist. Agra fort, Uttar Pradesh to the effect that today on 06.02.2023, during special van duty vide Pradhan Nagar PS GDE No. 327/23 Dt. 06.02.2023 along with force C/762 Mojibar Rahaman CV/242 Rakesh Mongar, CV/645 Pankaj Gupta, CV/128 Ajay Kr Sahani all of Pradhan Nagar PS, SPC. I received one specific input that two persons possessing two bags each has been standing there suspiciously at Siliguri Junction under Pradhan Nagar PS, SPC. The matter was diarized and subsequently, I informed the matter to you and as per your kind order, and being directed, I along with force had been to Siliguri Junction under Pradhan Nagar PS, SPC and being pointed out by my source, detained 02 (two) persons at Siliguri Junction and I started asking them regarding their identity and reason for them coming there. At this time, they disclosed their identity as above but they were giving different statement at different times. As suspicion grew, I called two independent witnesses namely Raju Paswan s/o Joginder Paswan of Gurung Busty, PS Pradhan Nagar, Dist Darjeeling and Sudhir Kumar s/o Bhumi Prasad of Coolie Para, Ward No. 1, ps Pradhan Nagar, Dist. Darjeeling and subsequently, searched the apprehended Keshov Kumar Sharma and Shivam Soni and their belongings.

On search of the bags of the conscious possession of above noted Keshov Kumar Sharma and Shivam Soni, silver ornaments, likely to be silver could be recovered. On asking said Keshov Kumar Sharma and Shivam Soni failed to produce any valid documents in support of possessing the above noted silver ornaments, likely to be silver and after prolonged interrogation they revealed that they have procured the said articles clandestinely and was going to dispose of illegally at adjoining areas of Bihar. Further, being interrogated, they admitted that all the stolen articles recovered from their possession are stolen from Siliguri and its adjacent areas and, remaining articles have been procured from their other associates. Accordingly, I seized the above noted recovered silver ornaments, likely to be silver under proper seizure list in presence of independent witnesses. The whole process of seizure was made in between 21.40 to 23.45 Hrs. Subsequently, I arrested them U/S- 41 Cr.P.C issuing Memo of Arrest and informing the ground of their arrest.

After arresting the above mentioned accused persons, I along with force and with the accused persons went to Jewelry shop to weigh the silver ornaments and was weighted 21 kgs 761 grams in presence of independent witnesses.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Keshov Kumar Sharma (M/27), S/O- Sri Mahesh Prasad Sharma of Bankim Nagar, Ward No. 41, PS Bhaktinagar, Dist. Jalpaiguri, Sonihome, Bholechouhan Road, PS Bhelringa, Dist. Jalpesh and (ii) Shivam Soni (26) s/o Hari Om Verma of 18/137 Bherogari, Devijeke, Mandir, Mathura, PS Kotwali, Dist. Agra fort, Uttar Pradesh and others and arrange for its investigation.
