Sir,

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Kajal Mandal (45) s/o Lt. Subal Mandal of Kalaramjote Ranidanga PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Fifteen (15) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as exhibit-A in which 01 bottles taken as sample for examination exhibit-A1.
2. Seven (7) sealed Bottles of Mc Dowells No. 1 Luxury Premium whisky, each bottle 180 ml, Marked as exhibit-B in which 01 bottles taken as sample for examination exhibit-B1
3. Five (5) sealed Pouch of Officers choice Grand whisky, each pouch 180 ml, Marked as exhibit-C in which 01 Pouch taken as sample for examination exhibit-C1

I am submitting a written complaint against the above noted accused person to the effect that today on 05.02.23 at 21-05 hrs received a secret source of information that one person was selling ld Liquor illegally from one shop styled as Raj Laxmi Hotel at Rangapani Bazar under PS Bagdogra to its customers without any valid license. Accordingly I informed the duty officer of Bagdogra PS and O.C. Bagdogra PS and as per his instruction myself along with ASI Jakirul Islam C/851 Chandan Debnath VP- 02 Pradip Roy CV- 386 Kishor Hawlder VP-01 Ansalam Kujur left for Rangapani Bazar under PS Bagdogra to verify the veracity of information which diarised vide Bagdogra PS GDE No. 227 dt. 05.02.23. On arrival at the spot at 21-35 hrs it was found that one person mentioned above was selling liquor illegally from the Raj Laxmi Hotel to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, On being asked he disclosed his name and address mentioned above. Thereafter in the presence of witnesses I recovered the above noted articles from the said shop styled as Raj Laxmi Hotel and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt and stated that one Rintu Sarkar is owner of the said Raj Laxmi Hotel and the owner of that Shop sells liquor from his shop through him and on seeing police the owner Rintu Sarkar managed to flee away from his shop to avoid police arrest. As such I arrested the above noted accused person u/s 41 Cr.P.C. as it's a violation under Bengal Excise Act. The seizure & arrest was made in between 21-45 hrs and 22-15 hrs (seizure Total approx 11.3 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the person namely (1)Kajal Mandal (45) s/o Lt. Subal Mandal of Kalaramjote Ranidanga PS Bagdogra Dist. Darjeeling and (2) Rintu Sarkar, owner of the shop styled as Raj Laxmi Hotel at Rangapani Bazar, PS bagdogra and arrange for its investigation.
