Sir,

I, SI Laksang Bhutia of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Ajay Kr. Singh (38) s/o Lt. Kishan Deb Singh of Chowpukuria, Kestopur PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Fifteen (15) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as exhibit-A in which 01 bottles taken as sample for examination exhibit-A1.
2. Six (6) sealed Bottles of Mc Dowells No. 1 Celebration Matured XXX RUM, each bottle 180 ml, Marked as exhibit-B in which 01 bottles taken as sample for examination exhibit-B1

I am submitting a written complaint against the above noted accused person to the effect that today on 06.02.23 at 15-15 hrs received a secret source of information that one person was selling Liquor illegally from his house at Chowpukuria, Kestopur under PS Bagdogra to its customers without any valid license. Accordingly I informed the duty officer of Bagdogra PS and O.C. Bagdogra PS and as per his instruction myself along with ASI Jakirul Islam C/851 Chandan Debnath VP- 02 Pradip Roy, CV- 389 Janak Singh, VP-01, Ansalam Kujur left for Chowpukuria, Kestopur under PS Bagdogra to verify the veracity of information which diarised vide Bagdogra PS GDE No. 356 dt. 06.02.23. On arrival at the spot at 15-45 hrs it was found that one person mentioned above was selling liquor illegally from his house to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in the presence of witnesses I recovered the above noted articles from his house and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 15-55 hrs and 16-35 hrs (seizure Total approx 10 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the person namely Ajay Kr. Singh (38) s/o Lt. Kishan Deb Singh of Chowpukuria, Kestopur PS Bagdogra Dist. Darjeeling and arrange for its investigation.


