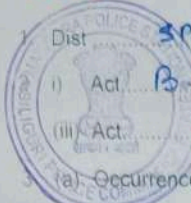

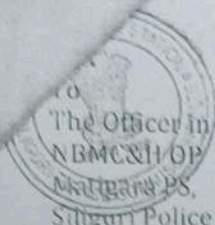

Sir,

In producing herewith one arrested accused person namely Gobinda Babu Mallick (M-50) S/O-Lt Bahadur Babu Mallick of Kalamjote (Near Tozi's House), PO Sushruta Nagar, Dist Darjeeling along with seized articles (i) 29 (Twenty Nine) Bottles of 70 UP Country Spirit styled as **HIMALAYAN FATAFATI** of 300 ml each when packed, MRP Rs. 28/- each (ii) 01 Nylon Bag which used for carrying the seized articles SL N-) 01

I, ASI Anupam Roy of North Bengal Medical College & Hospital OP under Matigara PS SPC do hereby lodge a written complaint against the above noted accused person to the effect that today on 06/02/2023 at 18:35 hrs during evening RT mobile duty I received secret source information that, one person is stocked up huge quantity of country spirit at his house situated at Kalamjote. Accordingly I informed the information to OC NBMC&H OP and as per his direction I along with C/327 Barkat Ali Ahammed and C/1085 Mithun Debnath left for PO to workout the information. On arrival at Kawakhali at 18:45 hrs being pointed out by the source, we conducted raid in the house of Gobinda Babu Mallick S/O-Lt Bahadur Babu Mallick of Kalamjote PO Sushruta Nagar, Dist Darjeeling and recovered total 29 Bottles of 70 UP Country Spirit styled as **HIMALAYAN FATAFATI** of 300 ml each when packed, MRP Rs. 28/- each bottles. On demand he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Kalamjote and adjacent area illegally with a view to earn huge money for his lively hood. On interrogation he disclosed his name and address as Gobinda Babu Mallick (M-50) S/O-Lt Bahadur Babu Mallick of Kalamjote (Near Tozi's House), PO Sushruta Nagar, Dist Darjeeling. Accordingly I seized 29 (Twenty Nine) Bottles of 70 UP Country Spirit styled as **HIMALAYAN FATAFATI** of 300 ML each bottles under proper seizure list also labeled the same in presence of witnesses and duly sign by them as well as by the arrested accused person and arrested him. The seizure was made between 19:05 hrs to 19:25 hrs. and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 812/- (Eight hundred and twelve) only.

Under the above circumstances I am submitting this written complaint against the above accused person namely Gobinda Babu Mallick S/O-Lt Bahadur Babu Mallick of Kalamjote PO Sushruta Nagar, Dist Darjeeling for starting a specific case under proper section of law and to arrange for its investigation.
