Sir,

With reference to the subject cited as above, it is intimated that some miscreants had entered to our premises and stole 2 nos. of DG batteries (Exide make, bearing serial no. 16445 & 26187) costing about Rs. 40000/- last night. They have also broken the iron grill put on the boundary wall before entry.

In this regard, it is pointed out that the 200 KW medium wave transmitter spread over 22 acres of land is a vital installation of Govt. of India. It is usually found that many antisocial elements/drunks are loitering around the premises and engage in many notorious activities.

Hence, it is requested that regular patrolling may be carried out in the area and the culprit of the theft incident may be captured at the earliest.
