Bankim Dasgupta, 2nd Floor, Saptashi Apartment, Nazrul Sarani, E.V.Pally, Ward No-38, Rabindra Sarani, Siliguri, Dist- Jalpaiguri for having committed offence as stated here under.

On 06.02.2023 at about 04.40 p.m. acting on a source information I, along with 1) Sri Amarasish Mahandeo, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Rana Dasgupta and inspected service installation, metering installation of Consumer ID 401425613 in the name of Lt. Bankim Dasgupta. During inspection it was found that electricity was being used unauthorisedly & illegally by Rana Dasgupta by reconnecting the disconnected service line of the metering installation that was disconnected previously on 06.09.2017 due to meter surrender.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Bente Electricals & Elec Ltd, serial no.- B3587249 Installed against Con Id. 401425613 seized by preparing a formal seizure list duly signed by representative of Rana Dasgupta and witnesses. The copy of the seizure list handed over to representative of Rana Dasgupta and his signature obtained as token of receipt against Rana Dasgupta, (PH NO- 7365064465) S/o- Lt.
