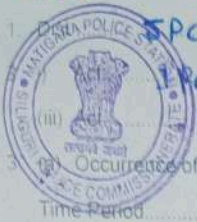


Subject: Request for registering an FIR against Professor Bijoy Kumar Sarkar, Professor, Department of History, University of North Bengal for outrage of modesty and causing mental harassment of Dr. Dipsikha Acharya at workplace.

Dear Sir,

This is to inform you that, after four and half years of service in the Department of History, University of North Bengal as Assistant Professor, I have repeatedly faced outrage of modesty and workplace harassment by Professor Bijoy Kumar Sarkar, Professor, Department of History, University of North Bengal, and on 3rd February 2023, he tried outraging my modesty in front of the faculty members of the department as well as research scholars. On 3rd February 2023, around 1.00 PM -1.30 PM during the Ph.D. synopsis presentation of two research scholars Mamun Sarkar and Prosenjit Roy, in the chamber of the Head, Department of History, University of North Bengal, Professor Bijoy Kumar Sarkar insulted my modesty by making filthy and humiliating remarks on my qualification and my professional and academic competence, threatened me and also he shouted at me on top of his voice in front of the departmental faculty members and research scholars. It is quite evident that he has some malign intentions of causing mental and physical harm to me and thus I feel extremely unsafe and insecure of his future actions within and outside the NBU campus. On innumerable previous occasions since my joining in the Department on 17th September 2018, he has been repeatedly humiliating, ragging, bullying and threatening me which has caused a severe damage to my health both physical and mental. I also officially as well as informally complained to various authorities of NBU, but the issue was never properly addressed. Therefore I humbly request you to take stern legal action against Prof. Bijoy Kumar Sarkar and provide me a strong safeguard against outrage of my modesty as a woman and threatening at workplace.
