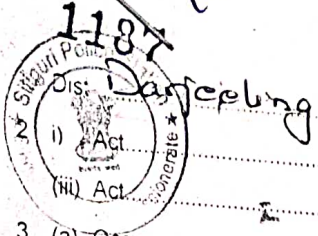

Sub: FIR against Pilferage of Electricity

Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that *Mr. Amit Das (User), S/O- Sanjib Das, resident of Rabindra Nagar (near Rabindra Sangha Club) (Ward No.- 21), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412024194), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose as stated here under.*

On 08.02.2023 at about 13:10 Hours, I, Sri Sourav Paul, AE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Pranab Sikdar, Special Officer (S&LP) attached with Darjeeling Region, WBSEDCL & 2. Mr. Arnab Ray, J.E. (E) (Grade-II) & 3. Mr. Biplab Sarkar, Sr. Office Executive, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of *Mrs. Uma Das (Late), W/O- Sanjib Das at Rabindra Nagar (near Rabindra Sangha Club) (Ward No. - 21), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412024194), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.*

During inspection it has been found that the aforesaid accused, *Mr. Amit Das (User), S/O- Sanjib Das, resident of Rabindra Nagar (near Rabindra Sangha Club) (Ward No.- 21), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412024194), was consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnecting the 'Deemed Disconnected' service connection having Consumer ID: 412024194 & Meter No.: G01888870 which was disconnected on 28.07.2018 having outstanding dues of electricity Rs. 50,426.61 (excluding LPSC). It may be added to the context that last meter consumption recorded before disconnection was 2560kWH on 28.07.2018. Moreover, during inspection the last reading was found 10141kWH on 08.02.2023. Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.*

As Theft was detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number Energy Meter having SI No.: G01888870, make: Genus, Rating: 240V, 5-30A, 3200 imp/kWH, Mfg.: 04/2017 along with some portion of two numbers each of incoming & outgoing wires which have been used for Unauthorized reconnection of the 'Deemed Disconnected' service connection with the LT Pole side (Consumer ID: 412024194) at the mentioned Domestic premises for the Domestic purposes dishonestly in unauthorized manner under a proper seizure list duly signed by the Inspection Team Members & the Accused Person. The seized articles were properly packed, labeled and sealed at the spot after observing all formalities. However, Copies of Notice, Inspection Note & Seizure List were handed over to the accused person, Mr. Amit Das on receipt. The inspection team members left the aforesaid premises at 13:45 Hours on the same day after observing all formalities.

So the accused *Mr. Amit Das (User), S/O- Sanjib Das, resident of Rabindra Nagar (near Rabindra Sangha Club) (Ward No.- 21), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412024194), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose.*

So I request you to take cognizance against the said Amit Das (User) on this matter and consider this complain as FIR to initiate further necessary action from your end.
