Sir,

In producing herewith one (01) accused person named Mohsin Margub Alam (28), S/O- Basiruddin of Asharubasti, Ghimigaon, PS. Chopra Dist- Uttar Dinajpur under arrest along with following seized articles;

- (i) One iron made improvised Fire Arms having its trigger, hammer and firing pin measuring approx 7.5 Inch including its butt, body and barrel [The articles have been found kept concealed on the waist of accused Mohsin Margub Alam & marked as 'Exhibit-A']
- (ii) Four (04) numbers of live ammunition inscribed as "KF" and "7.65" on percussions cap of each ammunition kept inside left pocket of Jeans Pant of accused Mohsin Margub Alam & marked as 'Exhibit-B'
- (iii) One blue colour Redmi Note 7 Pro mobile phone having IMEI No - 867224041622356 & 867224041622364 which was found kept inside right pocket of Jeans Pant of accused Mohsin Margub Alam, and marked as "Exhibit- C".

I, SI Basudeb guha of Siliguri PS, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person to the effect that today on 08.02.2023 at about 16.35 hrs received a secret information from my secret source that one person had been waiting at NTS More under PS- Siliguri for committing heinous crime and he used to carry and possess small arms & ammunition with him. Accordingly I requested him to come and identified the accused. Wasting no time, I diarised the information in Siliguri PS General Diary Book vide GDE NO- 487 Dated 08.02.2023 and consequently informed the tip off to you for kind instruction. Subsequently, on being directed, I along with ASI- Siben Sarkar, ASI Debasish Das, ASI Subir Sen CV/622 Ramanath Barman and CV/283 Prasenjit Dey left Siliguri PS at 16.45 hrs for perusing the information by Govt. Vehicle. This refers to Siliguri PS GDE No- 489, Dated- 08.02.2023. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

We reached at NTS More at 17.05 hrs and contacted two independent witnesses namely i) Ajay Giri(34), S/O Abad Giri (6297826483) and ii) Narayan Sarkar(28) S/O Mahandra Sarkar (8436310171) both of Tikiapara, W/No-28, PS- Siliguri, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Subsequently, after contacting my secret source and being informed and identified I along with my accompanied officer and force conducted raid at NTS More in presence of witnesses and apprehended the above noted accused person named Mohsin Margub Alam as identified by my secret source. Searched him immediately and found the above noted articles from his conscious and exclusive possession kept concealed in his ossession.

Subsequently, being interrogated, the apprehended accused person disclosed his identity as noted above. Further being interrogated he admitted that he has collected the said Fire Arms and ammunitions from Tahirul Islam @ Rana of Bhangamari Fatapukur, Rajganj, Jalpaiguri. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused named Mohsin Margub Alam exclusively & consciously possessed this improvised fire arms with live ammunitions illegally with some ill motives.

Thus, when his involvement in carrying and possessing illegal fire arm established, I seized and labelled the above noted articles at the spot under proper seizure list duly signed by him as well as by the above noted independent witnesses and also put my signature on the seizure list and label. I also arrested him preparing memo of arrest informing him ground of his arrest.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused Mohsin Margub Alam has carried the said fire arms with live ammunitions with an objective to commit heinous crime in the locality.


So, I pray before you for starting a case against Mohsin Margub Alam (28), S/O- Basiruddin of Asharubasti, Ghimigaon, PS. Chopra Dist- Uttar Dinajpur under proper section of law as he has wilfully violated the regulation of Arms Act and for arranging its investigation.
