This is to bring to your kind notice that I, Shri, Kaushik Paul, aged 45 years, s/o Late Santosh Kumar Paul of 36/1 Rasbehari Sarani, Hakim Para, Siliguri, ward No. xvi, would like to lay before you the following facts:-

That, my wife Smt. Nilanjana Paul who stays with me has been regularly physically assaulting me for last 7-8 years without any provocation.

That, on, 07.02.2023 at about 10 am she assaulted me with metal rod without any provocation after which I went to my uncles house, shri, Paritosh Paul (place), who after seeing my condition suggested that this type of incident is becoming too frequent and for my safe-guard, on the advice of elders I went to Siliguri District Hospital.

That, on examination the Medical Officer has seen the abrasion and bruise marks on my left little finger, back and both the legs. The same report is enclosed herewith for your kind perusal and necessary information.

That, for peace of mind I shall henceforth, be staying in my relative's place away from Siliguri as of now (onwards).

Kindly treat this matter with urgency as you deem fit. This is for your kind information.
