Sir,

In producing herewith two (02) arrested accused persons namely (1) Pratap Thapa (34 yrs), s/o – Jimba@Gambir Singh Thapa Of Salugara near Gumba, P.O-Saligara, w/No. 42, SMC, PS – Bhaktinagar, Dist- Jalpaiguri (not verified) and (2) Shiba Chakraborty(32) S/O. Shanta Chakraborty of do along with the following seized articles under seizure as per seizure list –

- (i) 300 gms. seems to be **brown sugar**, found inside in a scooty bearing no. WB-74-BM-3610, wrapped in a transparent plastic bag, marked as Exhibit "A".
- (ii) One (01) black and blue color TVS Scooty bearing registration no. WB-74-BM-3610.
- (iii) One (01) OPPO Mobile phone being model CPH-2387 being IMEI No. 86283506125845.
- (iv) One (01) VIVO Mobile phone being IMEI No.865752050434695.

I, SI Rakesh Debnath of Ambari Falakata Out Post under NJP PS, Siliguri Police Commissionerate do here by lodge this written complaint against the above noted persons to the effect that today on 10/02/2023 at about 18:05 hrs received a specific source information that two persons are coming from Gajaldoba towards Siliguri by Scooty who carrying huge quantity of brown sugar with them for its clandestine disposal. Accordingly the matter was diarized vide Ambari Falakata OP GDE No-334, Dated – 10.02.2023 and informed the matter to O/C Ambari Falakata OP in writing a letter to him and expressed the entire information. As per kind direction myself along with ASI. Biswajit Ghosh, ASI. Rabi Tamang, C/824 – Styaban Das and L/C-741 Mallika Roy all of Ambari Falakata OP under NJP PS, Siliguri Police Commissionerate left for Nowapara Canal More under Ambari Falakata OP by Govt. Vehicle having no – WB 62A/7050 to verify the veracity of information vide Ambari Falakata OP GDE No 334, Dated – 10.02.2023 corresponding M.C.C No – 137/2023, Dated – 10.02.2023 and also communicate with mobile van and direct them to remain present at Nawapara More.

At the time of departure from Ambari Falakata Out Post I, took envelope, white paper, sealing wax, gum, seal, digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 18:20 hrs we arrived at Nowapara Canal More under Ambari Falakata OP, PS – NJP, Dist – Jalpaiguri and called two (02) independent witnesses namely (i) Pranab Chowdhury, s/o – Lt. Surat Kumar Chowdhury, of 9 No Colony, PO – Kamarvita, PS – NJP, Dist – Jalpaiguri and (ii) Tapan Roy, s/o –Rajeshwar Roy of Sankar Para, PO. Danzapara, PS – Kotwali, Dist – Jalpaiguri who were present at there and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and as witnesses of entire process under relevant provision of law. After a sometime as identified by the source we found that two persons were coming from Gajaldoba side towards Nowapara Canal More side with Scooty having no WB-74-BM-3610 which matched with the information. Accordingly we have stop them and on being asked the apprehended persons disclosed their identity as (1) Pratap Thapa (34 yrs), s/o – Jimba@Gambir Singh Thapa Of Salugara near Gumba, P.O-Saligara, w/No. 42, SMC, PS – Bhaktinagar, Dist-Jalpaiguri (not verified) and (2) Shiba Chakraborty(32) S/O. Shanta Chakraborty of do. After disclosing our identity we detained the above noted persons with strong reason to believe that they have illegally possessing said to be Brown Sugar inside their scooty which they were carrying for supplying the same to their designated customers for their wrongful gain. On being asked they confessed that they have possessed the said to be Brown Sugar inside their scooty for supplying the same to their designated

customers as per requirement and they came there for transportation the same. I then gave them option whether they wanted to be searched in presence of the Executive Magistrate or any Gazetted police officer. Then they agreed to be searched by any Gazetted Police Officer. Further I served them a notice in accordance with the provision of law in this regards. I also offered the independent witnesses and offered the accused persons to search our police party but they refused to search the Police Party. Then I sent C/824 - Satyaban Das with requisition to Special Executive Magistrate Sri Passang Topgay Bhutia, WBPS, ACP Traffic (East), SPC, Siliguri for supervise the whole process of search & seizure. At 19:05 hrs he returned at the spot with Sri Passang Topgay Bhutia, WBPS, ACP Traffic (East), SPC, Siliguri in uniform who disclose his identity to the detained persons as well as witnesses. Under the supervision of Passang Topgay Bhutia, WBPS, ACP Traffic (East), SPC, Siliguri and in presence of two independent witnesses search was conducted of the detained persons by following all formalities. After conducting search in their wearing apparels found nothing. Then conducting search their black and blue color Scooty and found the above noted seized articles noted in Sl. No. 1, which was kept inside the said Scooty. On demand in presence of the Spl. Executive Magistrate they failed to produce any valid documents in support of possessing said to be Brown Sugar.

Accordingly I weighted the said to be Brown Sugar by weighting instrument of Nowapara Canal More Grocery Shop of one namely Prasan Kumar Roy, s/o -Lt. Harendra Nath Roy of Nowapara More, PS - NJP, Dist - Jalpaiguri and found total 300 gms. Said to be Brown Sugar in one transparent plastic packet and marked as Exhibit" A". Then I have taken 5gms said to be Brown Sugar from mother packet as a sample which marked as Exhibit" A1". Therefore I labeled and sealed all the articles in presence of The Spl. Executive Magistrate Sri Passang Topgay Bhutia, WBPS, ACP Traffic (East), SPC, Siliguri and independent witnesses and accused persons. I then seized the above noted articles under proper seizure list and labeled duly signed by the above noted witnesses and the Spl. Executive Magistrate Sri Passang Topgay Bhutia, WBPS, ACP Traffic (East), SPC, Siliguri and acknowledge by the accused persons. The seizure was made in between 19:15 hrs to 19:55 hrs. On further interrogation the apprehended persons confessed in presence of The Spl. Executive Magistrate Sri Passang Topgay Bhutia, WBPS, ACP Traffic (East), SPC, Siliguri and other independent witnesses that they procured seized said to be Brown Sugar clandestinely from elsewhere for the purpose of selling the same in high rate to their designed customers for their personal gain by illegal means. On interrogation they disclosed that they have been dealing in such business of selling the Brown Sugar illegally for last 01 year. Then I arrested the above noted accused persons after observing all guidelines of Hon'ble Apex Court as well as after disclosing the cause of arrest and issued necessary memo of arrest. Thus arrested accused persons named (1) Pratap Thapa (34 yrs), s/o - Jimba@Gambir Singh Thapa Of Salugara near Gumba, P.O-Saligara, w/No. 42, SMC, PS - Bhaktinagar, Dist-Jalpaiguri (not verified) and (2) Shiba Chakraborty(32) S/O. Shanta Chakraborty of do (not verified) as violated the terms and condition of Narcotic Drug for possessing Brown Sugar without any valid authority or license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (1) Pratap Thapa (34 yrs), s/o - Jimba@Gambir Singh Thapa Of Salugara near Gumba, P.O-Saligara, w/No. 42, SMC, PS - Bhaktinagar, Dist-Jalpaiguri (not verified) and (2) Shiba Chakraborty(32) S/O. Shanta Chakraborty of do and arrange for its investigation.


