Sub : Complaint against 1. Smt. Anita Mohanta, wife of Sri Ananta Mohanta, 2. Sri Ananta Mohanta, Son of Late Daikhya Ram Mohanta, both are resident of Ranadip Colony, Patiram Jote, Post Office & Police station- Matigara, District- Darjeeling, 3. Arati Mohanta, wife of Amit Debnath and 4. Amit Debnath, father's name not known, both are resident of Babupara near Krishna Kunja Bhawan, opposite Indian Bank, Siliguri, District- Darjeeling, for physical and mental cruelty inflicted upon me and for demanding a sum of Rs. 5,00,000/- (Rupees Five Lakh) only.

Respected Sir,

I, Rina Mohanta nee Ray, wife of Sri Nil Kamal Mohanta, resident of Ranadip Colony, Patiram Jote, Post Office & Police station- Matigara, District- Darjeeling, would like to state that I am the legally wedded wife of Sri Nil Kamal Mohanta, Son of Sri Ananta Mohanta and Smt. Anita Mohanta and our marriage was solemnized on 13.03.2019 according to the Hindu religion, vaidic rites and ceremonies at my parental house situated at Bakshipara, Raninagar, District- Jalapiguri. That our marriage was arranged by both the families and at the time of marriage my in-laws has demanded certain articles including jewelry, furniture and other utensils which were provided by my parents and other relatives. That after my marriage my husband took me in my matrimonial home at the address mentioned above and since then we are living there as husband and wife. That in the said marriage my parents did everything without requiring my husband and in-laws to spend anything on any account. That within 3 months of marriage my mother-in-law Smt. Anita Mohanta and sister-in-law Arati Mohanta used to abuse me in filthy languages that I was unable to conceive a baby and used to taunt me every time about my physical condition. That due to cruel behavior towards me by my mother-in-law and sister-in-law I was forced to leave my matrimonial home and went to my parental house

situated at Bakshipara, Raninagar, District- Jalpaiguri. That after passing few days my mother-in-law and sister-in-law came to my parental house and complaint about my physical condition to my parents and abused them in such a slang languages which I can't express in words, they even used to abuse me as to why I am unable to conceive a baby and told me that I am a bitch who is ruining their life and threatened me with dire consequences not to come back in my matrimonial home as they were looking for a bride for my husband for a second marriage and they went away. By the mercy of god after one week I conceived and informed my husband as such my husband came a day later alongwith his maternal sister and took me in my matrimonial home and when we will reach there my mother-in-law and sister-in-law started to quarrel with me and did not let me to enter into the house and threatened to the maternal sister of my husband that "who are you to bring back her in my house, you should took her and left her in her parental house" as such I opposed them and tried to make them understand 'that our marriage was arranged only after you all have consented to the same and then only I got married with your son considering fire as a witness as such I will not leave my matrimonial home' but they are stubborn in nature and was very much determined to threw me out from my matrimonial house, my mother-in-law and sister-in-law beat me with wooden batam in presence of my husband and maternal sister of my husband after knowingly well that I was pregnant and heated in my back and tried to heat in my womb with an intention to cause miscarriage but somehow my husband rescue me in their hands. That thereafter we have waited for a long time outside of my matrimonial house till my parents and other respectable persons has not arrived there and with the help of my parents and other neighboring people I were able to enter into my matrimonial house alongwith my husband. That out of the wedlock between me and husband I gave birth to a male child on 13.03.2020 and I was busy in upbringing of my child. That thereafter due to the outbreak of novel corona virus (SARS-CoV-2) that causes COVID-19 a nationwide lockdown was declared by the Government of India and was extended by the State Government from time to time, my husband lost his job and we were facing some financial problems, my mother-in-law used to quarrel with my husband about the financial issues and accordingly she started to inflicted physically and mentally cruelty upon me and threatened me to bring back a sum of Rs. 5,00,000/-

(Rupees Five Lakh) only from my parents but I refused to do the same and narrate them my father is a farmer by occupation and in such a pandemic situation he could not manage such a huge amount, however my father considering my well being have manage a sum of Rs. 15,000/- (Rupees Fifteen Thousand) only which was provided by me to my mother-in-law. That after a month when my husband was not in home, they again started to create mental pressure upon me to bring money from my parents but when I refused the same my mother-in-law, father-in-law Sri Ananta Mohanta, sister-in-law, and husband of my sister-in-law Amit Debnath have increased their cruelty upon me and beat me with fist and blows and threatened me with dire consequences that they will kill me or otherwise threw me out from my matrimonial house if I not bring money from my father for them. I have endure such torture over the period of time in the hands of my in-laws and every time I forgive them to think that one day everything will become fine and we will live happily together in one shed structure. That since I have gave birth to my son, my mother-in-law and father-in-law was not happy and they have feeling of hatred towards my minor child and me extend to such a height that on the day of rice ceremony of my son they went away somewhere else and return a day after when the ceremony was performed. That my mother-in-law and sister-in-law used to keep open the gas oven intentionally so that I will die alongwith my minor child as such on 24.06.2022 I had lodged a written complaint before the Inspector-in-Charge, Matigara Police Station narrating the entire incident but later on due to intervene of my husband I had withdraw the said complaint thinking about the well being of my in-laws as such no action was taken against my in-laws. That in the month of November 2020 my son was suffering from ear's pain as such we have consulted a doctor and after diagnosis we have come to know that my son has a hole in his eardrum and the doctor has advice us to keep the ear of my son's clean and dry and also provided drop. That we had told about the health condition of my son to my mother-in-law but she is stubborn in nature did not used to adhere our words and used to put mustered oil in our son's ear whereas the doctor was strictly inhibit us to do the same and when I oppose my mother-in-law not to put the mustered oil she used to told me that the doctor has given a wrong advice to us and we are not bound to listen each and every advice of the doctor, not only this my mother-in-law even used to massage my son using kerosene oil with an

intention to cause health issues and when I tried to oppose her she will start quarrel with me. That I had made a written complaint against the concerned police authority thrice against the torture inflicted upon me and my child and on every occasion I have to withdraw the complaint just thinking about my marital tie with my husband. That my father-in-law, mother-in-law and sister-in-law with an intention to throw me out from my matrimonial house has increased their torture time and again and as such I alongwith my husband and minor child was forced to live in the godown in my matrimonial house since the month of October, 2022 where no facility of sanitation, kitchen was there and the whole area is open but somehow I alongwith my husband living there with our minor child, we had built a temporary half wall open bathroom without door and living our life in such a misery. That on 09.02.2023 at about 10 p.m. when my husband was not in home my mother-in-law and father-in-law having lathi in their hands came to me and threatened me to leave my matrimonial house or else they will beat me alongwith my minor child but somehow I manage to stop them and requested them not to do such act as such they have gave me two days of ultimatum or else they will throw me out from my matrimonial house alongwith my minor child.

Under such constrained circumstances I hereby lodging this complaint against my in-laws 1. Smt. Anita Mohanta, wife of Sri Ananta Mohanta (mother-in-law), 2. Sri Ananta Mohanta, Son of Late Daikhya Ram Mohanta (father-in-law), 3. Arati Mohanta, wife of Amit Debnath (sister-in-law) and 4. Amit Debnath (husband of sister-in-law) father's name not known and would request you to kindly investigate the matter and do the needful as soon as possible in this regard so that wrongdoer can be punished as per the procedure established by law.
