commit some cognizable offence and were about to move from the spot. Seeing police personnel approaching towards them, they tried to flee away but on a hot chase we managed to apprehend above noted two (02) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Dagapur area.

I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 02.45 hrs to 03.30 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them and brought the arrested accused persons along with seized article at Pradhan Nagar Police Station. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Dagapur area. It is also revealed from they alongwith 7/8 some others had assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons namely (i) Sujit Prasad (28y/M), S/O. Lt. Bharat Prasad of Shibnagar, Darjeeling more, Ps. Pradhannagar, Dist. Darjeeling (not verified) and (ii) Satyam Rai(22y/M), S/O. Sunil Rai of Below Govt. College, Diocean Gaon, Ps. Singmari, Dist. Darjeeling (not verified) and others and arrange for its investigation.
