Matigara, Siliguri would like to state that the above named persons had come to my house at 12.30 midnight today and started shouting outside and when I went to see, they pelted stone to me with the intention to kill me. They abused, shouted and threatened to kill me. Had Police Party not been on time I would have been killed.

It is pertaining to state that civil, criminal and Case under domestic violence has been pending before the Ld. Courts at Siliguri and in the civil and domestic violence case restraining orders have issued against Sanyog Tamang and his mother and also against Sumit Mitruka and his wife Narika Mitruka.


