I, Khalid Nizami, son of Shekh Muhammad Nijamuddin, resident of ward No.- XIII of Gulebag, Mohammadabad, Ghazipure, Uttar Pradesh, would like to lodge this complaint that my father was the recorded owner-in-possession of the land measuring 3.43 Acre, under R.S. Plot No.- 165 corresponding to L.R. Plot Nos.- 614, 615, 626, 627 and 653, recorded in R.S. Khatian No.- 8/5, situated at Mouza- Panchkelguri, within Police Station- Matigara, Dist.-Darjeeling.

Sir, Md. Salman, Son of Md. Paniya, Md. Jagir, Son of Md. Zaharu, Md. Hashu, Son of Md. Zaharu and Chota Jagir, son of Md. Samaru @ Saniya, all are residents of Panchkelguri, P.S.- Matigara, Dist.- Darjeeling and Paresh Saibo, son of Late Kartick Saibo, resident of Mansara Jote, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, along with my one brother viz. Md. Moazzam Ali had illegally made a secret plan to sell my father's entire land completely ignoring the rights of other legal heirs of my father including myself viz. Salahuddin Nizami, Ziauddin Nizami, Mahetalet, Riazuddin Nizami, Rashid Nizami, Nishat Talat, Mushir Ahmed Nizami and accordingly, said Md. Moazzam Ali, in collusion and in connivance with the aforesaid persons, had falsely prepared one forged, illegal and false Power of Attorney being No.- 29 of 2019, registered at the office of the Sub-Registrar, Mohammadabad, Uttar Predesh, by impersonating and forging several documents, photographs and signatures with a clear dishonest intention to cheat me and other legal heirs of my father and also misappropriate the entire consideration money of my father's land, by falsely representing other persons as my father's legal heirs.

Sir, said Md. Moazzam Ali with the help of Md. Salman, Son of Md. Paniya, Md. Jagir, Son of Md. Zaharu, Md. Hashu, Son of Md. Zaharu and Chota Jagir, son of Md. Samaru @ Saniya, and Paresh Saibo, son of Late Kartick Saibo, had manipulated and manufactured the Khatian of my father and procured one L.R. Khatian in the name of Md. Moazzam Ali with the office of the B.L. & L.R.O., Matigara.

Sir, subsequently, by illegally making transaction of a mere amount, the aforesaid persons have falsely and illegally took registration of the aforesaid land in the name of Airin Nasrin, Azima Khatun, Zahanara Begum, Md. Salman, Seikh Kush Mohammad and Nazma Khatun immediately, after obtaining the said false, forged, manufactured and fabricated

Power of Attorney for misappropriating a huge amount near about Rs. 1 Crore and thereby cheat me and other legal heirs of my father from the legitimate claim of our inherited land/property.

Sir, on enquiry, I have come to learn that it is a clear conspiracy of Md. Salman, Son of Md. Paniya, Md. Jagir, son of Md. Zaharu, Md. Hashu, Son of Md. Zaharu and Chota Jagir, son of Md. Samaru @ Saniya, and Paresh Saibo, son of Late Kartick Saibo, Md. Moazzam Ali and the aforesaid subsequent purchasers viz. Airin Nasrin, Azima Khatun, Zahanara Begum, Md. Salman, Seikh Kush Mohammad and Nazma Khatun and said Md. Ismile, Ravindar Narayan Rai and Guddu Jadav, who have jointly distributed the entire consideration money in between themselves, keep myself and other legal heirs of my father in dark.
