That my wife namely Chand Tara Khatoon on 05-02-2023 went to Siliguri District hospital for her checkup around 10:00am by herself from then till now she did not come back in home and her mobile phone is also switch off. I and my all family members searching everywhere but we did not found any trace of her.

After searching every possible places, we got an information through one will wisher namely AlokBoro, Son of not known , resident of Missamari, Sonitpur Assam pin 784506, that one Nikky Hussain, son of Kadir Hussain, resident of Missamari, Sonitpur, Assam - 784506, has locked my wife in room in Assam.

That one criminal case has lost already registered in Pradhan Nagar Police Station before on 05-11-2021 being a ~~file~~ case number 898/21 and a trial is going on in Siliguri court and the said accused person. Nikky Hussain is on ~~bail~~ now due to the previous case out of anger and frustration for taking revenge he kidnapped my wife. We called the said Nikky Hussain various time and asked about my wife but he and his family members denied completely but the said Alok Bora neighbour of Nikky Hussain informed us my wife still in their home and they locked my wife in a room.

That all his family members i.e;

1. Kadirhussain, s/o Mohammad Miya

2. AysaKhatoon , w/o kadirhussain

3. Raja Hussain, s/o Kadir Hussain

All are involved in this matter.

Therefore I request you to kindly investigate the matter and take the necessary legal step as soon as possible for the ends of justice.
