In producing herewith following seized articles viz.

1] 15 (Fifteen) bottles of Himalayan Fata Fati Country Spirit (each bottle containing 300 ml, Total= 4.5 liters, value Rs 28 \* 15 = 420/-)

I, ASI Sajal Das presently posted at New Jalpaiguri Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that today (12.02.2023) at 21.25 hrs, I receive a specific source information that one person namely Bablu Roy (51) S/O Lt. Keshab Mohanta Roy of Gora More, P.S- NJP, Dist- Jalpaiguri is engaged in selling of illicit liquor at his hotel at Thakurnagar Railgate under NJP P.S . Accordingly, I informed the matter to Officer in Charge, NJP P.S and I also diarized the matter vide NJP P.S GDE No. 548 Dtd. 12.02.2023. As per permission of superior, myself along with VP/ 13 Jamirul Islam, CV/306 Biswajit Roy and CV/824 Niru Kr Yadav all of New Jalpaiguri PS, Siliguri Police Commissionerate left P.S to verify the veracity of source information. At about 21.45 hrs. myself along with forces arrived at Thakurnagar Railgate area and had been to the hotel of Bablu Roy (51) S/O Lt. Keshab Mohanta Roy of Gora More, P.S- NJP, Dist- Jalpaiguri and found that the aforesaid person had been selling illegal liquor to the common customers at his hotel at Thakurnagar Railgate area under New Jalpaiguri PS jurisdiction. Then I cordoned the place with my accompanied forces but while on the time of cordoning off the place, the aforesaid person along with the persons who were having liquor at that place manage to flee from the spot. On being search the above noted seized articles are found from his hotel. The seizure has been made in between 22.15 hrs. to 22.40 hrs. on 12.02.2023.

Under this above fact and circumstances, I pray before your good self that a specific case against the above noted accused person namely Bablu Roy (51) S/O Lt. Keshab Mohanta Roy of Gora More, P.S- NJP, Dist- Jalpaiguri may kindly be initiated under proper section of law and may cause for its investigation.
