I, the undersigned applicant, Smt. Babli Roy, W/O - Smt. Tapas Bhattacharjee, now residing at Natun Para, near Ramghat, Siliguri, Dist. Jalpaiguri (W.B.) and permanent resident of Saktiganh Road No. 4, P.S. New Jalpaiguri, Dist. Jalpaiguri (W.B.), do hereby wish to lodge this F.I.R. against the following persons -

- 1) Smt. Tapas Bhattacharjee (Husband), S/O - Lt. Kamal Bhattacharjee;
  - 2) Smt. Khokan Bakshi (Maternal Uncle in-law), S/O - Not Known
  - 3) Smt. Manju Bakshi (Maternal Aunt in-law), W/O - Smt. Khokan Bakshi
  - 4) Ms. Rinki Bakshi (Daughter of Maternal Uncle in-law), D/O - Smt. Khokan Bakshi
- all are residents of Saktiganh Road No. 4, P.S. New Jalpaiguri, Siliguri Dist. Jalpaiguri, West Bengal.

That I am residing with my husband at the aforesaid address for the last 7 years and two sons were born out of our wedlock. That since the initial days of marriage, my husband used to physically assault me on many pretexts and I used to bear all the pain for my children. But, due to increased alcoholic use, my husband used to be very much abusive on me and the other Accused Persons used to co-operate with him.

On 2/6/2022, my husband, along with the <sup>in laws.</sup> ~~other persons~~ an named had beaten me mercilessly and thrown me out of my matrimonial home and I had to take shelter at my parents' home. But, few days ago, my husband took me again to the matrimonial home on the pretext that he had understood his fault and wanted to start the conjugal life afresh. I reciprocated to him thinking about the welfare of my children.

But again, on 08/02/2023, my husband, in association with the above persons <sup>in laws</sup> had used abusive words to me by questioning my character and again thrown me out of my matrimonial home with physical assault and I was compelled to take shelter at a rented premises with two children, having no source of income and livelihood.

I am under great distress and I am victim of both physical and mental cruelty, regularly being committed by my husband and other persons as above-named.

That under the given facts, I do hereby lodge this F.I.R. against the above Accused Persons and to pray before you to kindly take necessary legal action against the above-named persons.
