This is to inform you that I am Labanya Kanti Roy, S/O: Tapan Kumar Roy, present residing address Suryasenpally, P.O: Kadamtala, Darjeeling, Project In Charge of Gajoldoba Eco- Resort-II, Gajoldoba Tourism hub, Gajoldoba, Jalpaiguri. Today i.e., on 14th of February, 2023, at morning at about 11:00 am when I was in site inspection, found that our installed 10 nos of wash basin Mixture (brass made), 2 nos of Shower Diverter (brass made), 7 nos gate valve (brass made), 10 nos water Diverter (brass made) of plumbing system and copper pipe & accessories (aprox 50 meter) for AC system of our Cottage-01 and Cottage -03 was theft from our ongoing resort project. It is our suspicion that the incident has been done by a mason (Plumber) with name Naresh Chowdhury who was residing inside our project for work. His father's name is Nageswar Chowdhury and his address is Debasish Colony, Dakshin Bhaktinagar, Siliguri, 734004.
