Sir,
In producing herewith the 02 (two) arrested accused persons namely (i) Krishna Das (36) S/O Lt. Bisad Das of Bakravita, P.S- NJP, Dist.- Jalpaiguri and (ii) Tarkeshwar Nath (28) S/O Lt. Param Hansh Sharma of Bhola More, P.S- NJP, Dist.- Jalpaiguri along with the following seized articles under proper seizure list :-

Total 05 Packet wrapped with Brown Colour Cello Tape containing Total 30.165 Kg [Thirty Kilo Gram and one hundred and sixty-five Gram] Approx of suspect to be Ganja Marked as follows :-

- (i) One Packet wrapped with Brown Color Cello Tape containing 06.399 Kg of suspect to be Ganja Marked as Exhibit-"A".
- (ii) One Packet wrapped with Brown Color Cello Tape containing 06.707 Kg of suspect to be Ganja Marked as Exhibit-"B".
- (iii) One Packet wrapped with Brown Color Cello Tape containing 04.20 Kg of suspect to be Ganja Marked as Exhibit-"C".
- (iv) One Packet wrapped with Brown Color Cello Tape containing 06.263 Kg of suspect to be Ganja Marked as Exhibit "D".
- (v) One Packet wrapped with Brown Color Cello Tape containing 06.596 Kg of suspect to be Ganja Marked as Exhibit "E".
- (vi) Two Plastic Bag
- (vii) One Multi colour nylon bag
- (viii) One white-red Color Hero Maestro scooty bearing registration No.- WB 74AG 4158 along with key.

I, SI Newton Biswas of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 02 (two) arrested accused persons to the effect that today 14.02.2023 at about 15.35 hrs I received a specific source input that two person is coming from Cooch behar side to Chaturagachh Samshan area with one scooty bearing registration No.- WB 74AG 4158 with huge consignment of Ganja for their clandestine disposal to their designed customers. The matter was diarized vide NJP PS PS GDE No. 631 Dt. 14.02.2023 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station, Siliguri Police Commissionerate in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Sajal Das, C/1439 Tapas Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy all of NJP PS, Siliguri Police Commissionerate being headed by me left for Chaturagachh, in front of Chaturagachh Samshan, under New Jalpaiguri PS, Dist.- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 632 dated 14.02.2023 and **M.C.C. No. 286/23 dated 14.02.2023**. Further I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Chaturagachh, in front of Chaturagachh Samshan under NJP P.S to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 14.55 hrs we arrived at Chaturagachh, in front of Chaturagachh Samshan, under New Jalpaiguri PS, Dist.- Jalpaiguri and on the way to the spot, I called two independent witnesses namely (i) Md. Raju (3S) S/O Md. Khaigar Ali of Paschim Dhantala, P.S- NJP, Dist.- Jalpaiguri (ii) Mustak Hussain (37) S/O Lt. Sanju Mia of do and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we apprehended One white-red colour scooty bearing registration No.- WB 74 AG 4158 is standing in front of Chaturagachh Samshan under PS-New Jalpaiguri, Dist.- Jalpaiguri with two person which was matched with our information. Accordingly, we intercepted the scooty and apprehended two person who disclosed their identity as noted above. One Krishna Das (36) S/O Lt. Bisad Das of Bakravita, P.S- NJP, Dist.- Jalpaiguri was found at rider seat of the scooty and one Tarkeshwar Nath (28) S/O Lt. Param Hansh Sharma of Bhola More, P.S- NJP, Dist.- Jalpaiguri was found as pillion rider.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused
(i) Krishna Das (36) S/O Lt. Bisad Das of Bakravita, P.S- NJP, Dist.- Jalpaiguri and (ii)
(28) S/O Lt. Param Hansh Sharma of Bhola More, P.S- NJP, Dist.- Jalpaiguri (Not verified) is
curing and selling of Ganja jointly and contravening the norms of NDPS Act was established,
the above noted 02 (Two) accused persons after observing all guidelines of Apex court of arrest
er disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of
Labelled and arrest was made in-between 17.40 hrs to 18.50 hrs on 14.02.2023.

Under the above noted facts and circumstances, I pray to you that a specific case under proper
may kindly be started against the above noted arrested accused persons namely (i) Krishna Das
Bisad Das of Bakravita, P.S- NJP, Dist.- Jalpaiguri and (ii) Tarkeshwar Nath (28) S/O Lt. Param
of Bhola More, P.S- NJP, Dist.- Jalpaiguri (Not verified) and others arrange for its investigation.
