I Dinesh Sahani (36) S/O Lt. Satyans Sahani, resident of Maharij colony (Near Kachra Math), Ward No. 4 SMC, P.O. Siliguri Bazar, P.S. Siliguri, Distt- Darjeeling, beg to inform you that on dt. 13/02/2023 at about 08:30 PM, my minor daughter namely, PINKI SAHANI (D.O.B 01.07.2005) is again kidnaped by one, Md. Cuddu S/O Md. Nizam, C/O Md. Mustaque of Maharij colony (Near Kachra Math) Ward No. 4 SMC, P.O. Siliguri Bazar, P.S. Siliguri, Distt- Darjeeling.

It is pertinent to say that, previously also my said minor daughter was kidnaped on dt. 25.12.2022 by the above named culprit and I had lodged a written complain at Khalpara T.O.P-II, on dt. 25/12/2022 and over the said complain, a specific case was started and my said minor daughter was recovered from Md. Cuddu noted above and she was kept at home at C.I.N.I. and took over by her mother, Smt. Saraju Sahani w/o Sri Dinesh Sahani, on dt. 26.02.2022, and since then she is with us at our house.

But again said Md. Cuddu kidnaped my said minor daughter, Pinki Sahani (17 yrs)

So, please take necessary action against said Md. Cuddu, who was temporarily residing with his uncle namely, Md. Mustaque of Maharij colony (Near Kachra Math) Ward No. 4 SMC, P.O. P.S. Siliguri, Distt- Darjeeling
