Sub: Complaint against St. Fernando College of Nursing and the Md Mukhtar Sekh.

Dear Sir,

With due respect I would like to inform you that I Sri Gopal Sharma, S/o- Late Gour Sharma, residing at shishunikatan school More, Babupara, Po+ Ps – Jalpaiguri, Dist- jalpaiguri. Priyanshu Sharma is son of my elder sister and I was admitted him in St. Fernando College of Nursing, Webel IT Park, Paribahan Nagar, Matigara, Siliguri- 734010 on 28<sup>th</sup> August 2021 for B.Sc. Nursing. At the time of admission the head of the college Md Mukhtar Sekh was committed us that they completed the B.Sc. nursing course from "Vanshika College of Nursing" at Bangalor, which is a INC approved Institute, but after one year five month latter the College authority declare that the examination of the B.Sc.Nursing course of their college student will held in "Sanjeevani Institute of Peramedical Science" at Bangalor But said College is not approved by INC. After heard this news I was visit in St. Fernando College on 31/01/2023 and ask to the head of the department Md Mukhtar Sekh that why he had change the College from Vanshika to Sanjeevani for priyashu's B.Sc. Nursing course and why he did not inform to the guardian before admission of the "Sanjeevani Institute of Peramedical Science" ? I had also inform him that I am not interested to continue the Nursing Course of Priyanshu at Sanjeevani Institute of Paramedical Science, because said college is not approved by INC. The head of the department Md Mukhtar Sekh did not give me any clear answer of my question and continuously miss behave with me and told me that if I did not interested to continue the B.Sc. Nursing course of Priyanshu at Sanjeevani Instite of Paramedical Science then quit Priyanshu from his college.

After all this incident I was submitted a letter by Priyanshu and Priyanshu withdrow from his course of B.Sc. Nursing from said St. Fernando College of Nursing, but the Office of the St. Fernando College received the application by

only one staff Signature and not by seal, I was told to said staff for receive the application by seal also but she did not do this and after that I had requested to said Md Mukhtar Sekh to return the original document which he was taken at the time of admission and also refund the money which he taken from me for this course of B.Sc. Nursing at Vanshika College of Nursing, But said Md Mukhter Sekh deny to refund the money and return the document. He told me that the original document deposited by them at Sanjeevani Institute of paramedical Science. Today i.e. 16/02/2023 I further visit at St. Fernando College of Nursing at About 2 PM and further requested to Said Md Mukhter Sekh to return the Original Document of Priyanshu but they did not return the original documents to me. After that I further ask him that why he had issue the kaccha money receipt? But he did not reply my question.

So, Sir I am fully cheated by said Md Mukhter Sekh and all staff of St. Fernando College of Nursing, because they did not use any registration number in there any document. They did not give any document or registration certificate of any College during that 15 month course time to priyanshu. They took the course fees and advance course fees from me for Priyanshu's B.Sc. Nursing Course but they did not give any authentic Money receipt to me and did not issued any authentic document about the course or college of my student. So, said Md Mukhtar Sekh and others Staff of said St. Fernando College fraud with me and my nephew Priyanshu and gave us false commitment to admitted in their St. Fernando College of Nursing Falsely and took huge money by cash as a Course Fees and advance course fees total Rs. 3, 30, 000/- ( Rupees Three Lakh Thirty Thousand) Only and spoil the 15 month time of my nephew Priyanshu Sharma and continuously try to spoil his future by took the original document in their custody and for this reason Priyanshu Sharma did not take admission in any other Institution.

So, in this circumstances, It is requested to you that please investigate this matter and help me to recover the original document and money from said St. Fernando College of Nursing and Md. Mukhtar Sekh and save the future of my nephew Priyanshu Sharma and give me justice to give punishment to the accused person for running the illegal institution and spoil the future of new generation student.

I am hopeful with you and thanking you.
