SUBJECT: COMPLAIN AGAINST ROHIT CHAUHAN, SITA DEVI (MOTHER),

Sir,

With due regard and humble submission I Smt. Rinku Mahato Wife of Sri Rohit Chauhan and Daughter of Sri Ram Srestha Mahato, resident of South Ambedkar Colony, Ward No-I (SMC), P.O & P.S- Pradhan Nagar, Siliguri, Dist- Darjeeling do hereby submit the following for your kind perusal and necessary action :-

- 1 That I was married to Rohit Chauhan S/O Rajendra Chauhan presently residing at Delhi, G Block-170, near Kitchen Exotica, Opposite of Pandey Medical Molar Band, extn., Badarpur Boarder NEW DELHI PIN 110044, according to Hindu rites and Customs on 5th February 2020 at Utsav Bhawan, Tumbajote, P.O & P.S- Matigara, Dist- Darjeeling.
- 2 That in my said marriage my parents had given all house hold Goods & articles i.e. utensils, cloths, which is needed to begin marriage life and Cash of Rs. 1,00,000/- , Golden Ornaments , One Scooty, as per demand of the in-laws and husband.
- 3 That after marriage my husband took me to his village Garahi , Dist- Vishali and then after three days he took me to his Service place at Delhi along with his all family members to lead conjugal life and for few days everything was well and good but after elapse of one month my in laws started to misbehave and use to abuse me in filthy language as my father has not given dowry as per their satisfaction and when I reported the matter to my husband but he did not paid any heed.
- 4 That my husband also started to torture me physically and mentally and as my husband always listen his parents and his sister who always made a conspiracy against me use to provoke / speak false thing about me to my husband in order to drove me out of the house.
- 5 That my husband and in laws use to abusing me frequently without any reason and torturing me physically and mentally and they also beat me as my parents did not fulfill their demand of dowry.
- 6 That my husband on each and every day us to assault / beat me like a butcher and create pressure upon me to bring money from my parents house to fulfill his desire.
- 7 That my husband is not paying money for my expenditure and when I demand from him then he use to beat me cruelly and ask me to bring from my parents house.
- 8 That my husband and in laws always torture me physically and mentally for want of money and I tolerated with a hope that one day my husband and in laws will change their behavior but all in vain and their behavior against me became more painful day by day .
- 9 That my husband and in-laws did not allow me to talk with my parents and if I intend then they all use to abuse me in filth language and beat me and threw my Mobile from my hand forcefully by using criminal force against me .
- 10 That after marriage my husband and in-laws did not allow me to meet with my parents and they did not allow me to go out of house and always took work from me like a maidservant and continuously torture me cruelly /physically and mentally as demands were not fulfilled .
- 11 That after one year when my father created pressure upon my in laws then my husband left me alone on 7/10/2022 at Delhi Airport and returned back and told me not to come again and he is not interested to lead Conjugal life with me anymore.

- 12 That my husband and in-laws never accepted me as wife /daughter in law and as my parents did not fulfill their illegal demand of dowry. And on several times they had attempt me to kill by strangulate my neck.
- 13 That my husband and in-laws has made my life hell and ruined my life for their ill motive.
- 14 That my husband and mother in-laws is always threatening my over mobile and sending men to my parents house and they threaten that if any complaint is filed against my husband and in laws then they would kill me and my parents as they have good relation with the antisocial elements of Bihar.

Under the above facts and circumstances you are requested to please take necessary legal action against my husband and in laws who have torture me physically and mentally for their illegal demand of dowry and who have ruined my life and also try to kill me for their ill motive, for which I shall be highly oblige .
