Sir,

with due respect I beg to report that I Santosh Kumar, s/o Late R. C. Choudhary aged 46 years, residing at Flat No-3A/A, Sankalp Enclave, Chayan Para, Near Manokamna Flour mill, check post, P.S- Bhaktinagar, Dist- Jalpaiguri like to state that my wife named Shilpi Kumari aged 36 years committed suicide by hanging with the ceiling fan of our bedroom on 16/02/2023 at around 2:30 - 4:00 PM in absence of me and my children. It is here to be noted that ladies of ntpc works and hard forced the caretaker of society to upload a video involving the deceased on "Sankalp Enclave" whatsapp group and ntpc member (ladies member as well as the gents member) started abusing in sheet whatsapp group immediately. Ladies of ntpc works also started abusing the deceased in the "Sankalp Enclave ladies group" continuously. Some of the name of the ladies are Khushboo Gupta, wife of JK Shivastava, Bharat Kumar, Poity (wife of Biswanath), wife of U. K. Paul, Kiran Bhabhi, and a lot of other man/woman in Sankalp Enclave, all the past are available in my whatsapp and some past also available in deceased whatsapp. Ladies whatsapp group also abuses the deceased and Ms. Khushboo posted the profile pic of the deceased and Ms. Khushboo commented on the post of Khushboo Gupta.

1, the husband of the deceased talked over the phone to some member and asked for help and requested him to advise their wife to kindly wait for some day for amicable solution. But none of them responded positively. Then I advised my wife to wait for 4/5 days when I returned from my today's duty at Regional office, Siliguri, where I was busy in handing over the MS/BA plate 14mm & 16mm to TCS-IV officer.

All the incident took place today i.e. on 16/02/2023. From 10:00 AM onward. My strong belief and as told by my wife after seeing the whatsapp post got disturbed and continuously telephoned me, but I could not understand that she could take such a extreme step. Some of the ladies today after posting the whatsapp also, shouted in front of my door, which include also Mrs. Prashant and other ladies except the wife of Mr. Nirmal Aggarwal. Some of the other ladies also shouted and laughed in front of the balcony of my flat, due to which she also got very disturbed.


She was a very simple and well educated lady belonging to a respectable family and wife of Bharat MS Soni, continuously abused her in the premises of society and also frequently scolded my kids. The mother of Arya also one day come to my house and scolded our children in front of her.

My strong belief is that due to the continuous
humiliation today i.e. on 16/02/2023, my wife

Hence, I pray to you that ~~you~~ strong legal action
against wife of Bharat Kumar, wife of J.K. Shrivastava,
wife of Biswasent, wife of Mr. Prashant, Kiran
Bhabhi, wife of V.K. Paul, wife of Suresh
(Khusbu Gupta) and other persons who had
posted harsh comment as well as the person
who posted the video and comments on
whatsapp group may be taken.
For which my wife committed suicide.
