Respected Sir

I, Puja Shaw@Sah, Wife of Dinesh Sah of of Hatiduba, Back side of Loknath Mandir, PS. Pradhan Nagar, Dist. Darjeeling do hereby complain you that as follows:-

- 1) That my marriage has been solemnize with one Dinesh Sah S/O- Hoti Lal Sah, resident of Hatiduba, Back side of Loknath Mandir, PS. Pradhan Nagar, Dist. Darjeeling (W.B). PIN 734003 as per Hindu rites and custom on dated 21 June 2018 at abovenoted residence, Siliguri and after my marriage I accompanied my husband to Hatiduba, Back side of Loknath Mandir, PS. Pradhan Nagar, Dist. Darjeeling (W.B), PIN 734003 and started to live there as husband and wife.
- 2) That at the time of marriage my father and family member has given 5,00,000/- rupees in cash as per the demand of the husband and the in- Laws and also given one Wooden Bed, Utensils and another Furniture, also given Golden Ornaments such as one Golden Chain, Earning, Bangles rings, Payel, Mangalsutra and another ornaments but the husband and in -Laws are not satisfied with such articles ornaments, furniture's and cash and demand more cash from my parents soon after the marriage my husband, father In-law, mother-in-Laws and sister in- laws started to demand more 5,00,000/- (Rupees Five Lac) cash and from my parents and my family member and when I express Inability of my mother and my family member to satisfied their such exorbitant and Illegal demand my husband, mother-in-law used to assault me verbally and physically in front of in-laws and in-laws use to remain silent spectator and did not protest illegal acts my husband and also use it integrate my husband for such illegal demand.
- 3) That I use to all such torture of my husband and in-laws thinking that everything will be fine with the passage of time and also for the families, but with the passage of time the level of torture and cruelty started to increase.
- 4) That my husband is a habitual drinker and came late at night in drunken condition and use to quarrel with me in trifle issues and When I use to serve food to my husband he used to criticized me for such cooking and in front of me he use to throw the meal I serve to him and whenever I try to protest such act of my husband he use to beat me severally with hand, feet and lathl whatever he find in his hand and constantly threat me to drive me out of my matrimonial house and none of my in-laws ever protested such illegal and wrongly act of my husband. Due to such torture I become seriously ill and bed ridden but I was not allowed to take medical treatment by them.
- 5) That started to blaming me that I have extra martial affair and did not allow me to talk on mobile phone even with my parents so that I may leave the house out of their such torture and my husband may marry again with another Lady and again demand huge cash.
- 6) In the mean time I got pregnant, and at the time of my pregnancy they used to torture me both physically and mentally as well as torture conducted unnatural sexual intercourse in the aforesaid manner and started to pressurize me to abort my child and used to tell me that as I have not fulfilled their such demand they do not want my child from me as they have to marry again my husband with another Lady. Conclusively on dated 2nd October, 2021 one male child born namely Divyansh Sah.

7) That yester night i.e., on dated 15-02-2023 approximately 11:30 pm. my husband Dinsh Sah, father -in-law Hoti Lal Sah, Mother-in-law namely Dewarati Sah, Sister in-law namely Anita Sah physically assaulted me brutally I fled away from my in-laws house alongwith my son and went to Siliguri District Hospital for proper treatment otherwise yester night my husband and all in-laws sure killed me.

8) That due to unbearable torture of my husband and above noted in-laws, I take shelter at my parental house at Vivekanand Nagar, Ward No.42, SMC, P.O. Salugara, P.S. Bhaktinagar, Dist- Jalpauguri.

So, therefore I request you to please take all necessary legal steps against my husband namely Dinesh Sah, Mother-in-law namely Dewarati Sah and my father-in-law namely Hoti Lal Sah and sister in-law namely Anita Sah for the ends of Justice.
