With due respect, I am producing herewith 05 (five) arrested accused persons namely (i) Dip Roy (26 yrs) S/O Umesh Roy of Jyoti Nagar, Bhangapool, PS- Matigara, Dist.- Darjeeling (ii) Sanjoy Roy (23 yrs) S/O Jagadish Roy of Lalpool, Baniakhari, PS- Matigara, Dist.- Darjeeling (iii) Pradip @ Lambu Barman (24 yrs) S/O Late Parshuram Barman of Nabin Jote, near Sibananda Ashram, PS- Matigara, Dist.- Darjeeling (iv) Sikendar @ Sonu Gupta (36 yrs) S/O Suresh Prasad Gupta of Matigara Bazar, PS- Matigara, Dist.- Darjeeling and (v) Hari Banerjee (20 yrs) S/O Ganesh Banerjee of Rana Nagar, PS- Matigara, Dist. Darjeeling and the following articles under seizure :-

1. One sharp cutting weapon called as "Bhojali" & one torch light recovered and seized from the possession of accused Dip Roy S/O Umesh Roy of Jyoti Nagar, Bhangapool, PS- Matigara, Dist.- Darjeeling.
2. One sharp cutting steel made knife and one torch recovered and seized from the possession of accused Sanjoy Roy S/O Jagadish Roy of Lalpool, Baniakhari, PS- Matigara, Dist.- Darjeeling
3. One sharp cutting weapon called as "HASUA" recovered and seized from the possession of accused Pradip @ Lambu Barman S/O Late Parshuram Barman of Nabin Jote, near Sibananda Ashram, PS- Matigara, Dist.- Darjeeling.
4. One Sharp cutting iron made knife recovered and seized from the possession of accused Sikendar @ Sonu Gupta S/O Suresh Prasad Gupta of Matigara Bazar, PS- Matigara, Dist.- Darjeeling.
5. One iron made Sabol and one sharp cutting knife recovered and seized from the possession of accused Hari Banerjee S/O Ganesh Banerjee of Rana Nagar, PS- Matigara, Dist. Darjeeling.

I, SI Goutam Mallik of Matigara PS, Siliguri Police Commissionerate beg to state that on 18.02.23 at 01.05 hrs received a reliable secret source information that a gang of miscreants assembled at Goel Biscuit Factory Ground under PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Rabindra Pally area under Matigara PS. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 875 dated 18.02.23 and informed the fact the Officer-In-Charge, Matigara PS, SPC. As per his kind order and direction myself along with ASI Tapan Das, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, C/974 Mintu Sen, CV-155 Sukumar Das and CV- 387 Sukumar Barman all of Matigara PS, SPC left for Goel Biscuit Factory Ground under PS- Matigara, Dist.- Darjeeling to verify the veracity of said source input vide Matigara PS GDE No 875 dated 18.02.23. I also informed the fact to Night RT Van officer PSI Abhijit Banik and ASI Abdul Latif both of Matigara PS and directed them come at near Goel Biscuit Factory Ground to accompany with us. At 01.25 hrs we arrived at near Goel Biscuit Factory Ground under PS- Matigara, Dist.- Darjeeling. After a few time RT Van Officer PSI Abhijit Banik and ASI Abdul Latif along with force came at near Goel Biscuit Factory Ground under PS- Matigara, Dist.- Darjeeling and accompany with us. At about 01.45 hrs as indicated by the source we noticed that 10/11 persons assembled in a dark place at Goel Biscuit Factory Ground and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 05 (five) of them with deadly weapons in their possession but 05/06 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity in a house at Rabindra Pally area. On search the above noted weapon of offence recovered from their possession. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made on 18.02.23 in between 02.25 hrs and 03.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 05 (five) arrested accused persons namely i) Dip Roy (26 yrs) S/O Umesh Roy of Jyoti Nagar, Bhangapool, PS- Matigara, Dist.- Darjeeling (ii) Sanjoy Roy (23 yrs) S/O Jagadish Roy of Lalpool, Baniakhari, PS- Matigara, Dist.- Darjeeling (iii) Pradip @ Lambu Barman (24 yrs) S/O Late Parshuram Barman of Nabin Jote, near Sibananda Ashram, PS- Matigara, Dist.- Darjeeling (iv) Sikendar @ Sonu Gupta (36 yrs) S/O Suresh Prasad Gupta of Matigara Bazar, PS- Matigara, Dist.- Darjeeling and (v) Hari Banerjee (20 yrs) S/O Ganesh Banerjee of Rana Nagar, PS- Matigara, Dist. Darjeeling and others 05/06 unknown persons and arrange for its investigation.
