On 16.02.2023 at about 12.40 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Sunil Agarwal & Mukesh Kr Singhal and inspected service installation, metering installation of Consumer ID 401103260 in the name of Rita Agarwal. During inspection it was found that user Rita Agarwal supplying electricity from the energy meter of Consumer ID 401103260 unauthorisedly and illegally to the disconnected & defaulted premises of Consumer ID 412207648 in the name of Mukesh Kr Singhal that was disconnected previously on 09.01.2023 due to non-payment of outstanding energy bill.

As unauthorised supply of electricity to the disconnected & defaulted premises was detected through the energy meter make Bentec, serial no. B2109407 installed against Con Id. 401103260 seized by preparing a formal seizure list duly signed by representative of Rita Agarwal and witnesses. The copy of the seizure list handed over to representative of Rita Agarwal and his signature obtained as token of receipt.

As Rita Agarwal w/o Sunil Agarwal have committed offence u/s 135(1)(e) of Electricity Act 2003 by supplying electricity illegally & unauthorisedly to the disconnected & defaulted premises, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
