1. One Cartoon containing 04(four) plastic packets of white colour powder suspected to be heroine measuring packet(A) 751 gm,packet (B) 533gm,packet(C) 579 gm, packet(D) 570 gm. Total weight 2.433 kg( without cartoon box),2.761 kg with card board cartoon box and marked as Exhibits "X".
2. One white colour bag styled as Safed Detergent Powder.
3. One vehicle (Bus) having registration no.WB 73B 9983(Maa Sandhya Coochbehar-Siliguri) and key of bus.
4. One R.C book in respect of vehicle registration no. WB 73B 9983.
5. One driving license having number WB7319930030838 in the name of Mukul Sarkar.
6. one white colour mobile phone model no-S73 built Lava having IMEI No-(i) 911535051542838 (ii) 911535051857830 having number 9635783333, pattern-lock 7586.
7. one Lava light blue colour mobile phone having IMEI no-(i) 356827715116394 (ii) 356827715116402 having no-7384119792.

I do hereby lodge a written complaint Suo Moto to the effect that on 17.02.2023 at 08.30 hrs I received an secret source information from my reliable source over phone that a bag styled as "Safed Detergent Powder" containing a consignment of 2.5 K.G approx heroine would be transported by three persons who are the driver, helper and conductor jointly on board a passenger Bus named as "Maa Sandhya" having registration number WB 73B-9983. The source also informed me that the said consignment would be in a card board cartoon box packed within a white bag styled as "Safed detergent powder" and which would be coming from Coochbehar to Siliguri for deliver to drug dealers. Accordingly I noted the said information in the Darjeeling DD, CID ,West Bengal, GD book vide GDE No-70 date 17.02.2023 and also informed the same to SS(North), Siliguri, CID, West Bengal and obtained permission to work out the information.

Accordingly myself along with SI Md Safiqul Islam, SI Rohit Ranaphali, ASI Kamal Ch. Roy, WCT-168 Sujoy Das of Darjeeling DD, CID, West Bengal proceeded alongwith tool kit for Siliguri PS with Govt. Vehicle having registration No-WB-24Y/5919 driven by PD Sanjoy Pradhan of SAP 10<sup>th</sup> Bn, attached to Darjeeling DD, CID, West Bengal. Moreover SI Chabilal Sinha, SI Debabrata Singha, WCT-218 Abhijit Patowary, WCT/125 Sibendu Nandi, who are attached to SS ( North) office, CID, West Bengal joined us at Siliguri PS to work out the information. gram, Packet (B)-533gram, Packet(C) 579 gram, Packet(D)-570 gram. Total weight 2.433 Kilo Gram (without card board carton box) and 2.761 Kilo Gram with card board carton box.


Accordingly I seized the said articles and the passenger bus having registration number WB 73B- 9983 along with all connected papers and the key of the Bus under proper seizure list duly signed by the witnesses and the accused persons. After completion of the seizure, the articles was duly sealed and labeled. A copy of the seizure list was also handed over to the accused persons. The process of search, seizure and labeling was conducted between 12:40 hrs to 15:00 hrs under proper videograph in presence of a Magistrate and in presence of independent witnesses.

After completion of search and seizure procedures the weighing machine was also seized and returned in Zimma to the owner Mahesh Sharma s/o Lt Rajendra Sharma of Ganganagar, Road no. 2, ward no. 05, PS. Siliguri, Darjeeling.

The above noted three accused persons namely (1) Samir Sharma(M/43Yrs)(conductor), S/O Anil Chandra Sharma of Dariarpar,P.O- Kharija, Kakhrigari, P.S Pundibari, Dist-Coochbehar (2) Mukul Sarkar(M/45Yrs)(Driver),S/O Bimal Sarkar of Five Star club Taltola,Guriyahati-02,P.S-Kotwali,Dist-Coochbehar (3) Sanjay Dey(M/37yrs)(Helper), S/O Babuya Dey of Kolabagan Kaleshwari Chowpati ,P.O-Durgabari,P.S Kotwali,Dist-Coochbehar were then arrested under proper arrest memo and taken into custody.

Hence, it is requested that a case u/s 8( c )/ 21(C)/25/29 of N.D.P.S. Act 1985 may kindly be registered against the above noted accused persons.

It is requested that the investigation of the case may be endorsed to SI Pranay Sinchury of Darjeeling DD, CID, West Bengal.
