Sir,

I, Smt. Nidhi Singh, w/o Ranjeet Kumar Singh, d/o Sri Sanjay Singh, presently residing at Diesel Colony, Ward No. 1 of S.M.C., P.O. & P.S.- Pradhan Nagar, Dist – Darjeeling, PIN – 734003, beg to state that ray marriage with my husband Ranjeet Kumar Singh, s/o Bhanu Pratap Singh, r/o Ward No – 9, Village - Manikpur, Nawabganj, P.O. – Manikpur, P.S. – Fulkaha, Dist – Araria, Bih v., PIN – 854336, being an arranged marriage was held on 29/06/2017. There was pressure / emand for dowry from my in – laws including my father – in – law Bhanu Pratap Singh, mot ier – in – law Smt. Rekha Devi and brothers – in – law namely Ashish Kumar Singh, Ranjan Kumar Singh and Manoj Kumar Singh as well as from my husband Ranjeet Kumar Singh during my said marriage, claiming the same as their customs and conditions of marriage.

Despite my father's struggling life to maintain our family, he had to give Rs. 3,00,000/- (in cash), 1 gold chain, 1 gold ring and 1 Titan watch at the time of marriage, but this could not satisfy them, so 1 gold earring set, 1 gold chain, 1 gold ring, 20 voris silver along with utensils, steel bed frame set, godrej almirah, dressing table along with wearing apparels and other items was also given in me said marriage on the demand of my husband and in – laws. My father also made considerable expenditures during my marriage to his level best capacity and many friends, relatives and others also gifted many gift items. All these properties being my Stridhan properties are now being kept in the custody of my mother – in – law Smt. Rekha Devi and other in – laws, yea, I had to face ignominy from my husband and in – laws from the beginning. However, I withstood everything with the hope that with the passage of time everything will be normal, but although few months passed such attitude of my husband and in – laws could hardly be changed and my husband started to inflict torture upon me both physically and mentally with such discontentment over dowry and / or for more dowry in cash from my father. On 29/06. 2018, being my 1st marriage anniversary,

while I was 5 months pregnant and at my parental home, my husbandcame to my parental home and slapped me mercilessly accusing me of so many reasons and on the following day i.e. 30/06/2018 he behaved with me in a rude manner and pushed me forcibly and left me with immense mental shock and pain. Even after the birth of our child, he did not care to spend a single farthing. On 03/03/2019 at about 3:00 a.m. when I was at my matrimonial house, my mother - in - law and husband assaulted me with fists and blows for lame excuses and the other in - laws were silently supporting them. Even I was driven out from my room by my husband at night and was forced to spend my night outside my room with my infant child. Thereafter, on 11/06/2019 my father was injured in a road accident while driving a car, I with my worries and anxieties told my husband to go there, but he started abusing and assaulting me telling me 'let him die', however my father was brought to my in - laws house by some others and my husband and other in - laws started to misbehave with both of us, even abusing, beating and assaulting me mercilessly in front of my father and having had no alternative seeing my wretched condition my poor father had to bring me back to my parental house on 13/06/2019 and I was still not spared from their such threat and torture even after coming back to my parental home.

My husband and other in – laws time and again are conspiring together to take me back to their house to exploit me and / or to extort me and my father putting me at the risk of my life there. I am scared that anything may happen to my life at any time. On 10/02/2023 my husband with some others came to Silii ari to appear in a case filed by me u/s 125 of Cr.P.C against them which is pending before the Ld. Judicial Magistrate (3<sup>rd</sup> Court), Siliguri and made an attempt to kidnap me to take me back forcibly for their such purpose, but I escaped somehow. So long I had been waiting for any change in the attitude of my husband and in – laws, but all my dreams have been shattered and I am passing my days with mental shock and torture to my mind and person. Therefore, I am making this complaint in a delayed stage.

I therefore would like to request you to take appropriate action against the above named persons and also to recover my stridhan properties kept by them in their custody.
