Coul Depo, at that time, our neighbours namely (1) Md.

Sabir protested them they called their other relatives

Shamsud S/o Not known (9) Seida Khatun W/o Md.  
Halim & (10) Md. Halim S/o Not known, all are of  
Tehultala Majumdar colony, Ward No. 4, P.O. & P.S.-Siliguri  
Distt.-Dijeeley, and they also were equipped with Botam  
& bricks in their hands, and they all attacked on  
my mother namely, Nazma Khatun (SO) D/o Md.  
Sabir and injured her grievously.

We immediately shifted her at Siliguri Distt. Hospital  
and my said mother, Nazma Khatun (SO) admitted to  
Siliguri Distt. Hospital, and still under treatment therein.

So, please take necessary action against above  
noted 10 (ten) alleged persons.
