SUBJECT - COMPLAINT AGAINST LAND GRABBERS AND LAND MAFIA.

Respected Sir,

I beg to state that I along with my brother i.e. Ridam Tamang @Redam Tamang, s/o- Binod Kumar Tamang, are the joint owners having title and possession of a plot of land measuring 4 kathas and 12 chhataks, appertaining to R.S. Plot 873, corresponding to L.R. Plot 1952, recorded in L.R. Khatian No. 13489 and 13466, situated within Mouza - Baramohan Singh, under Matigara P.S.

That yesterday on 18/02/2023 at around 5 p.m., one Manojit Basak, s/o- unknown, along with his gang of 5-6 land mafias came to my property and tried to forcibly encroach and take possession of our property. These accused persons intimidated our labourers who were peacefully carrying out construction on our property. When I reached my land the accused persons threatened me and passed unparliamentarily and racist words against me. Manojit Basak and one of his men, called me "pahad ka adivasi gareeb" and said "tumharey pas ghar bananey ka paisa sab chori ka hain" "Tum log chor ho". Somehow with the help of well wishers and neighbours we were able to stop these accused persons to encroach our land. Furthermore when we inquired who they were and why are they disturbing the peace and tranquillity of the area, saying we are jungli and don't deserve to stay in this area, they further threatened us that they will encroach our land by force because they have leaders from political party and police on their side and they were very influential.

Sir, I am scared for my life and property, so would like to request you to take necessary action against this men who are threatening us to dispossess us from our land.
