Running Shop in the named "Haji Biryani" at Nivedita Road ,
Near Champasari More since many years.

1. That on 19.2.23 at about 11.30, at night a group of ~~6~~ ³⁻⁴ people came to shop in white coloured car and on red coloured one scooty bearing no-WB74BC3104 and entered the shop. Suddently 3 -4 persons among them gather at cash couner where my brother in law was alone alongwith my serving staff in shop.
2. That on demanding the money, one of them had pushed my brother in law at the corner and others were beating up.
3. That during on serving staff somehow managed rushed towards me about that.
4. When I reached there on, two more people from the car joined them and they all started to beaten up together badly.
5. One of them hit me badly with iron rod from backside, I was fallen down and seen that one of them taking cash from cash counter. one of my staff shouted chor chor

and While seeing the more people were arounding them, they runaway in their car with looted cash more than Rs 10,000 and leaving behind their scooty in hurry and vanished.

6. As I got badly injured and so with help my brother reached to siliguri District Hospital for treatment.

7. That later on again at aound 12.44 am on 20.2.23 , that white car came again in front of the gate warned the our members of dire consequences when I was in hospital for treatment.

So I Therefore request you kindly take necessary action against those person.
