Sir,

With due respect, I am producing herewith one arrested accused persons namely RajatChakraborty (38) s/o RatanChakraborty of Ambikanagar, Road No.- 01, PS-New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (Fifteen) Bottles of Himalayan Gold Country Spirit containing 600 ml in each bottle.

I, SI-PradeepDiyalipresently attached with NJP PS under your kind control beg to state that today i.e. on 16.02.2023. at 2235hrs I received a secret source information that one persons namely RajatChakraborty (38) s/o RatanChakraborty of Ambikanagar, Road No.- 01, PS-New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at his resident, at Ambikanagar Bazar, PS- New Jalpaiguri, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No.748 dated 16.02.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy, CV/824 Niru Kumar Yadav all of NJP PS, SPC left for Ambikanagar Bazar, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2245 hrs we arrived at Ambikanagar Bazar, PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the house of said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 2305 hrs to 2335 hrs on 16.02.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely RajatChakraborty (38) s/o RatanChakraborty of Ambikanagar, Road No.- 01, PS-New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
