Respected Sir,

I Mr. Nimesh Sarma S/o Late Mahesh Sarma designated general manager on behalf of our company M/s. Sakambari Flour Mills Pvt. Ltd. having its registered office and manufacturing facility at Mouza Ganda more, Bhutkihat, Po Balaram, Dist. Jalpaiguri.

Sir we are running a roller flour mill factory at the aforesaid premises and We had purchased a Qty of 2000 MT of FAQ Wheat under free market open sale scheme Auctioned by Food Corporation of India from FCI Cooch Behar Depot having address at FSD Khagrabari. After we made the entire payment of the sale consideration the Food Corporation of India issued us a Release Order cum Delivery Order enclosed here with marked as annexure "A".

Now since there is clout of truck mafias calling under a name of syndicate "Cooch Behar Truck Maalik Kalyan Samity" at FCI Cooch Behar depot, and they don't allow any party who has purchased wheat from the Cooch Behar to procure truck from outside free market and truck mafias forcefully supply trucks from there Cooch Behar Truck Maalik Kalyan Samity.

As we had sold around 500MT of wheat from the aforesaid purchases made by us from FCI Cooch Behar to TORSHA AGRO-TECH INDUSTRIES having its delivery address at "Plot No. 113/114 Part WBIIIC Growth Centre, PO Chakchaka- 736156, Dist. Cooch Behar (WB)" whose actual truck syndicate fare as per truck syndicate rate chart is Rs.1650 per MT but they forcefully collected a Ransome of Rs. 1850 per MT for 114MT and Rs.4750 per MT for 387MT over and above the regular freight charged by Cooch Behar Truck Maalik Kalyan Samity

We have also sold a Qty of 200MT to M/s Somnath Flour Mills Pvt. Ltd. at Rani Hat in Dist. Cooch Behar and the truck syndicate had forcefully collected an amount of Rs. 64800 as ransom over and above the regular freight charged by Cooch Behar Truck Maalik Kalyan Samity
