On dated 13.02.23 at about 1805 hrs No. 111871270 CT/GD Suman Biswasharma (Spot sentry) and No.111871270 CT Jinil A C (ACP No.3) observed some suspicious movements 02 miscreants/smugglers with cattle heads trying to cross the said cattles towards BD side, in the alignment of GIN 231 & BP ref. 732/3 S, BFL ref 13. On observing the miscreants, No. 111871270 CT/GD Suman Biswasharma (Spot sentry) and No.111871270 CT Jinil A C immediately rushed towards the spot and CT Suman Biswasharma fired 01 Rds of PAG Shot-8, Lot No. MHA 33 KF 09/15 by PAG Butt No. 76 Body No. 13 PG 06959 and seized 03 No's cattles Bengali origin medium size worth @ Rs. 14,459/- total Rs. 43,377/- as outgoing/unclaimed in unfenced area.

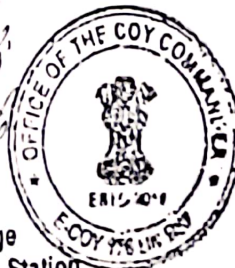
