It is to intimate that, on dated 16.02.23 based on specific 'G' info, a Spl Ptlg party lead by No. 130519973 SI/GD Amandeep Singh a/w 01 SO and 01 CT/G carried out search w.e.f 0600 to 0730 hrs in between IBBR and Village Kalangini. At about 0715 hrs, the ptlg party observed 05 unknown personnel and 04 Bengali origin medium size cattle standing in bamboo jhari, depth area near village Kalangini in the alignment of BFL No.11. On seeing the ptlg party, the Miscreants ran away towards village Kalangini. After that the party seized the 04 cattle @ Rs.14459 X 4=Rs.57,836/- as out going/unclaimed in depth area in the alignment of GIN No.231 & BP No.732/3S.
