With due respect, I am producing herewith one arrested accused person namely Binad@ Lambu Munda (46) s/o Lt. Lakhindar Munda of Odlabari Bagan, PO- Odlabari, PS- Malbazar, Dist- Jalpaiguri A/P Maa Hotel, Hotel line, PS-New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 14 (Fourteen) Bottles of Himalayan Gold Country Spirit containing 600 ml in each bottle.

I, SI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 19.02.2023. at 19.15 hrs I received a secret source information that one person namely Binad@ Lambu Munda (46) s/o Lt. Lakhindar Munda of Odlabari Bagan, PO- Odlabari, PS- Malbazar, Dist- Jalpaiguri A/P Maa Hotel, Hotel line, PS-New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at his Hotel, at NJP Hotel line, PS- New Jalpaiguri, Dist- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 893 dated 19.02.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy all of NJP PS, SPC left for NJP Hotel line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 20.05 hrs we arrived at NJP Hotel line, PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the Maa Hotel of said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his Hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his Hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his hotel. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.25 hrs to 20.55 hrs on 19.02.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Binad@ Lambu Munda (46) s/o Lt. Lakhindar Munda of Odlabari Bagan, PO- Odlabari, PS- Malbazar, Dist- Jalpaiguri A/P Maa Hotel, Hotel line, PS-New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
