Sub:- Complaint against my Daughter-In-Law namely Smt. Pinkl Maitra Ghosh, Wife of Sri Snehangshu Ghosh for causing tremendous mental and physical torture upon me and my wife and also for using filthy and abusive languages towards me in order to oust me and my family members from our own house.

Respected Sir,

With due respect I, **SRI JIBAN GHOSH**, Son of Late Joydeb Ghosh, Resident of Fire Bridged Road, Khalpara, Ward No. 09 of S.M.C., Siliguri, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, Pin: 734005, would like to lodge this Written Complaint to the effect that I am an old aged person (68 Years) and being a Senior Citizen, I have been suffering with severe old aged ailments since last few years.

Sir, Smt. Snehalata Ghosh (52 Years) is my legally married wife and out of our lawful wedlock, we have one son namely Sri Snehangshu Ghosh and one daughter namely Smt. Moumita Ghosh and both are married now and my said married daughter since the date of her marriage with Sri Bijoy Ghosh, has been residing at her matrimonial house situated at Airport More, Bagdogra, Dist. Darjeeling happily and peacefully.

My only son namely Sri Snehangshu Ghosh is also married and his marriage was solemnized on 02.03.2012 with Smt. Pinki Maitra, Daughter of Late Meghlal Maitra, of Netaji Colony, Ghogomali, Ward No. 36 of S.M.C., Siliguri, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, and after their marriage, they have started to live and cohabited together as husband and wife at our aforesaid residential address and I along with my wife including the other family members, being the in laws members, always gave our love and respect to my said daughter-in-law in all aspects and out of their lawful wedlock, one female child was born on 14.07.2015 whose name is Miss. Adrija Ghosh.

Sir it is pertinent to mention here that my father Jaydeb Ghosh (Since Deceased) was the absolute owner in possession of all that piece or parcel of a plot of land measuring 0.035 Acre, appertaining to and forming part of C.S. Plot No. 3174, recorded in Khatian No. 1510, of Mouza - Siliguri, J.L. No. 110(88), Sheet No. 3, Touzi No. 3(Ja)m Paragana - Baikunthapur, situates within the Ward No. 09 of Siliguri Municipal Corporation, Siliguri, falls under the Jurisdiction of Siliguri Police Station - Siliguri, Dist. Darjeeling, and my father had acquired the same by virtue of a Deed of Partition executed in between my father Jaydeb Ghosh (Since

Deceased) and Sri Keshab Chandra Ghosh and after acquiring the aforesaid land, he had constructed a house structure in and over the aforesaid land for residential purpose and subsequently, stated to reside therein along with the other family members and during the continuous possession of the aforesaid property, my father died intestate on 14.11.1992 leaving behind his wife Smt. Jogomaya Ghosh, myself, Ratan Ghosh, Basudeb Ghosh (Since Deceased) and two married daughters namely Smt. Jharna Ghosh and Smt. Krsihna Ghosh as his only legal heirs to inherit all his movable and immovable properties and thereby, I along with the other legal heirs of my father, became the absolute joint owners of the aforesaid property in equal share, having right, title and interest therein, free from all encumbrances and charges whatsoever.

Sir, there was no problem in our family and we used to maintain our daily life but it is very painful to mention here that after the marriage of my only son with said Smt. Pinki Maitra Ghosh, the atmosphere of our house become obnoxious as my daughter-in-law is not at all happy with the small earnings of my son and she always shows her desire to maintain a luxurious lifestyle outside the house though, it is very much within her knowledge as well as within the knowledge of her family members about the middle class family status.

Sir, since after their marriage, we along with our son have found and noticed that my daughter-in-law is a lady of bad character and she did not hesitate to use slang and filthy languages towards me and my wife and inspite of that, we used to give proper love and respect to her considering the future conjugal life of my son with a hope that in future she will definitely realize her own mistake and thereby, rectify themselves but all our hopes have gone in vain.

It is very painful to mention here that in the year of 2017, we came to know that our daughter-in-law has been maintaining an illicit extra marital affair with one person namely Pintu Hazra, of Ghogomali, and knowing the said fact, when my son made protest against her, she confessed her guilt before the entire family members and also assured us that she will not maintain such type of relation with any person in future and rectify herself and considering her said assurance and also considering the social prestige, we restrained ourselves from making any complaint against my daughter-in-law with a hope that she will definitely realize her own mistake and thereby, rectify herself but all our hopes have gone in vain and thereafter, again on 31.03.2018, she was caught red handed by my son while making some adulterous conversation with one person and thereafter, finding no other alternative, we along with our son informed the matter to her family members with a request to intervene into the matter and thereafter, with the intervention of her family members and also considering their assurance, we did not make any complaint against her before any authority and they have continued their marital relation bypassing the said activities of our daughter-in-law.

Thereafter, time and again, we found and noticed that our daughter-in-law became more furious day by day and she used to stay outside the house

most of the time on different pretexts and as and when either myself or my son asked her about her whereabouts, she did not hesitate to threaten us with dire consequences and also abused us with filthy and slang languages and on contrary, she also threatened us to oust us from our own house and during that time, she again told my son that she is not at all happy with him and she wants to lead her life luxuriously and if anybody tried to resist her, she will not hesitate to implicate them in a false criminal case and finding no other alternative, due to the continuous torture of our daughter-in-law, in the month of November, 2021, our only son has compelled to left our house and started to reside separately.

Sir, after leaving the house by my son, my daughter-in-law has started to cause tremendous torture upon me, my wife as well as my old aged mother both physically and mentally and she always created pressure upon us to vacate and handover the said property in her favour as she wants to lead and maintain herself lifestyle with the interruption of any person and when we refused to accept her said proposal, she became more furious and thereafter, she lodged a false complaint against us before the Siliguri (Women) Police Station incorporating a false story and on the basis of such complaint, one specific case has also registered against us and after initiation of the said case, we have voluntarily surrendered ourselves before the Court of Ld. A.C.J.M. at Siliguri and subsequently, released on bail and presently, we are on Court Bail.

Sir, since last few months, my daughter-in-law has started to create pressure upon us to transfer our aforesaid property in her favour and when I along with my wife and sons denied the same and make protest against her such type of demand, she became furious and started to abuse us with filthy and slang languages without considering our old age and also threatened us by saying that if I will not transfer the aforesaid property in her favour, she will not hesitate to implicate me and my entire family in another false criminal case and put us behind the iron bar and thereby, oust us from our own property forcefully and most illegally.

I, therefore, being a senior citizen, fervently requesting you to look into the matter properly and please take necessary steps against my daughter-in-law Smt. Pinki Maitra Ghosh, Wife of Sri Snehangshu Ghosh, as per the provision of law so that we can live our remaining life peacefully in our own property and obliged thereby.
